On 9 December 2011, the Company completed the acquisition of the entire issued share capital of Xinhua TV Asia-Pacific Operating Co., Limited. The aggregate consideration of the acquisition was agreed at HK\$700,000,000 which comprised HK\$92,969,790 by issuance of 474,335,664 shares at HK\$0.196 per share and HK\$607,030,210 by issue of 5% per annum interest-bearing convertible bonds at conversion price of HK\$0.196 per share and convertible into 3,097,092,908 shares (subject to pro-rata adjustments on capital structure changes).
