Note 1:

Moment to Moment holds 431,543,700 Shares, representing approximately 50.18% of the issued share capital of the Company. The sole shareholder of Moment to Moment is Harneys, the trustee of the Bar Pacific Trust, of which Ms. Tse and Ms. TK Chan, are the first batch of beneficiaries (Please refer to note 2 below). Pursuant to a deed of settlement dated 25 March 2014 in respect of the Bar Pacific Trust, Ms. C Chan is the protector of the Bar Pacific Trust, and Harneys is required to exercise the voting rights in any company the fund of the Bar Pacific Trust is invested in accordance with the joint written instruction from the protector (i.e. Ms. C Chan) and the settlor (i.e. Ms. Tse) of the Bar Pacific Trust. Each of Harneys, each of Ms. Tse, Ms. TK Chan and Ms. C Chan is deemed to be interested in the Shares held by Moment to Moment under the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) (the “SFO”).

Note 2:

On 7 June 2018, Mr. Chan and Ms. TT Chan became the beneficiaries of Bar Pacific Trust. Hence, both Mr. Chan and Ms. TT Chan are also deemed to be interested in the 431,543,700 Shares held by Moment to Moment under the SFO. Mr. Chan directly held 32,935,038 Shares.

Note 3:

9,632,000 award shares were granted to Ms. TK Chan, Ms. TT Chan and Ms. C Chan on 29 September 2023 pursuant to the share scheme of the Company adopted on 29 September 2023, subject to vesting according to the terms and conditions of the scheme. 3,210,667, 3,210,667 and 3,210,666 award shares were vested, allotted and issued to Ms. TK Chan, Ms. TT Chan and Ms. C Chan respectively on 2 October 2024; and 3,210,667, 3,210,666 and 3,210,667 award shares were vested on 29 September 2025, allotted and issued on 27 October 2025 to Ms. TK Chan, Ms. TT Chan and Ms. C Chan respectively; and 3,210,666, 3,210,667 and 3,210,667 award shares remained unvested for Ms. TK Chan, Ms. TT Chan and Ms. C Chan respectively as at 27 October 2025.
