The Company and its subsidiaries are an established one-stop environmental hygiene service provider based in Hong Kong. Its environmental hygiene services cover four types, namely (a) cleaning services; (b) pest management services; (c) waste management and recycling services; and (d) landscaping services. The Group provides environmental hygiene services to a wide range of venues including streets, cultural, leisure and recreational premises, residential premises, commercial buildings, markets, restaurants and academic institutions, etc. and its customers include various departments of the HK Government, property management companies and other corporations in the private sector. The Group first expanded its principal business in the online game industry by entering into its first online game licensing agreement with game developers in April 2024, pursuant to which, the licensor granted to the Group the exclusive, transferable and sub-licensable rights to promote, operate, publish, reproduce and distribute the licensed games and the products and services related thereto. The Group will continue to use its best endeavours to market and promote its licensed games to expand its online game business.
