### **QUARTERLY UPDATE ON THE IMPLEMENTATION OF ACTION PLANS TO REMOVE THE DISCLAIMER OF OPINION**

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of E-STATION GREEN TECHNOLOGY GROUP CO., LIMITED (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

References are made to the announcements of the Company dated 29 November 2024 and 31 December 2024, relating to, among others, (i) 2024 Annual results; and (ii) 2024 Annual Report (the “**Announcements**”). Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

The Board would like to provide the Shareholders and potential investors of the Company with the following updates on the Company’s actions in resolving the Disclaimer of Opinion.

As at the date of this announcement,

- (i) the Company continues to explore financing opportunities and considers various strategies to enhance the Group's operating income;
- (ii) two Chinese cuisine restaurants have commenced operations in the end of 2025 in Hong Kong. The Group considers that the new restaurants will generate sustained and stable income and profit for the Group in the future. Furthermore, the Company recently submitted a catering service tender proposal for a government-affiliated hospitality venue. The Company believes that successfully acquiring this tender would represent a significant milestone in diversifying the Group's revenue streams beyond traditional commercial dining into institutional and high-end club management. The Group will continue to explore further business opportunities to enhance its income source; and
- (iii) the Company is actively negotiating with the creditors for settlement schedules and/or settlement arrangements regarding outstanding payable. Certain creditors agreed to extend the settlement schedule to the year 2028.

The Board will continue to actively implement the plans and measures to the Disclaimer of Opinion and will publish further announcement(s) as and when appropriate.
