ANNOUNCEMENT PURSUANT TO RULES 17.50B AND 17.50(2)(h) OF THE GEM LISTING RULES

This announcement is made by Cool Link (Holdings) Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rules 17.50B and 17.50(2)(h) of the Rules Governing the Listing of Securities (the “**GEM Listing Rules**”) on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”). Reference is made to the announcement of the Company on 10 October 2025 (the “**Announcement**”). Unless otherwise stated, capitalised terms used herein shall have the same meaning as those defined in the Announcement.

The board of directors of the Company (other than Ms. Luk), has reviewed the Regulatory Announcement and the statement of disciplinary action referred therein and having regards to the background, expertise and contributions of Ms. Luk, considers that Ms. Luk remains suitable to act as an independent non-executive director of the Company as (i) the findings and conclusions set out in the Regulatory Announcement do not state that Ms. Luk is unsuitable to act as a director of a company listed on the Stock Exchange; and (ii) the incidents set out in the Regulatory Announcement do not involve any act of dishonesty or fraud concerning, or cast doubt on the integrity of Ms. Luk.

After thorough assessment, the Company considers that Ms. Luk has fulfilled the requirements under GEM Listing Rules 5.01 and 5.02, demonstrating that she had properly discharged her duties as a director of the Company. Accordingly, the Company confirms that Ms. Luk remains suitable to act as an independent non-executive director.
