**BUSINESS UPDATE**

This announcement is made by i.century Holding Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis to provide the shareholders and prospective investors of the Company with the latest business update of the Group.

The board of directors of the Company (the “**Board**”) is pleased to announce that the Group intends to explore the comprehensive development and utilization of ecological environment management as one of its potential long-term business directions, and to study the possibility of expanding its business in areas such as economic forest planting and processing of agricultural products, by conducting research on relevant industry trends and policy developments.

The Board considers that with China’s active promotion of ecological environmental management and the rural revitalization strategies, the comprehensive development and utilization of land resources has the potential to generate both social and economic benefits in the long run. The Group will assess relevant business opportunities in a prudent manner as and when appropriate.

In the course of its development, the Group has always adhered to the philosophy of stable operation and prudent investment. The Group’s exploration represents a forward looking consideration for its long term business layout. The Group will make further disclosures to the market in due course as its research progresses.

The Board wishes to emphasize that the above business directions are still at a preliminary stage, and the Group does not have any specific implementation plans or timetables in the short term. As at the date of this announcement, the Group has not entered into any legally binding agreements in respect of any specific projects, nor does it have any definitive investment commitments or funding arrangements. Should there be any progress in the relevant business directions, the Company will comply with the applicable requirements of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and will make further announcements in accordance with the GEM Listing Rules. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.

The Board is of the view that the aforementioned development direction will help the Group explore long-term development opportunities and create sustainable value for the Company’s shareholders in the long run.
