CHANGE OF COMPANY NAME, STOCK SHORT NAME AND COMPANY WEBSITE

Reference is made to the announcement of Jufeel International Holdings Limited (formerly known as Mindtell Technology Limited) (the “**Company**”) dated 2 March 2026 and the circular of the Company dated 29 April 2026 (the “**Circular**”) in relation to, amongst other things, the proposed change of name of the Company. Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that subsequent to the passing of a special resolution approving the Proposed Change of Company Name by the Shareholders at the annual general meeting held on 21 May 2026 and the issue of the Certificate of Incorporation on Change of Name by the Registrar of Companies in the Cayman Islands on 22 May 2026 certifying the change (the “**Change of Company Name**”) of the English name of the Company from “Mindtell Technology Limited” to “Jufeel International Holdings Limited” with effect from 22 May 2026, the Companies Registry in Hong Kong also issued the Certificate of Registration of Alternation of Name of Registered Non-Hong Kong Company on 25 June 2026 certifying the registration of the new English name of the Company under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong). The Chinese name of the Company remains unchanged as “九福來國際控股有限公司”.

CHANGE OF STOCK SHORT NAME

Following the Change of Company Name becoming effective, the English stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “MINDTELL TECH” to “JUFEEL” with effect from 9:00 a.m. on 8 July 2026. The Chinese stock short name of the Company, namely “九福來”, and the stock code of the Company, namely “8611”, remain unchanged.

CHANGE OF COMPANY WEBSITE

To reflect the Change of Company Name, the website of the Company will be changed to “www.jufeelinternational.com” with effect from 3 July 2026.

EFFECTS OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect the rights of existing Shareholder or the Company’s daily business operation and its financial position. All existing share certificates of the Company in issue bearing the former name of the Company shall continue to be valid evidence of legal title to such Shares and shall continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for the free exchange of existing share certificates for new certificates bearing the new name of the Company. Any issue of share certificates of the Company thereafter will be in the new name of the Company.
