- **Revenue in 2022 : NTD 3.15 billion**

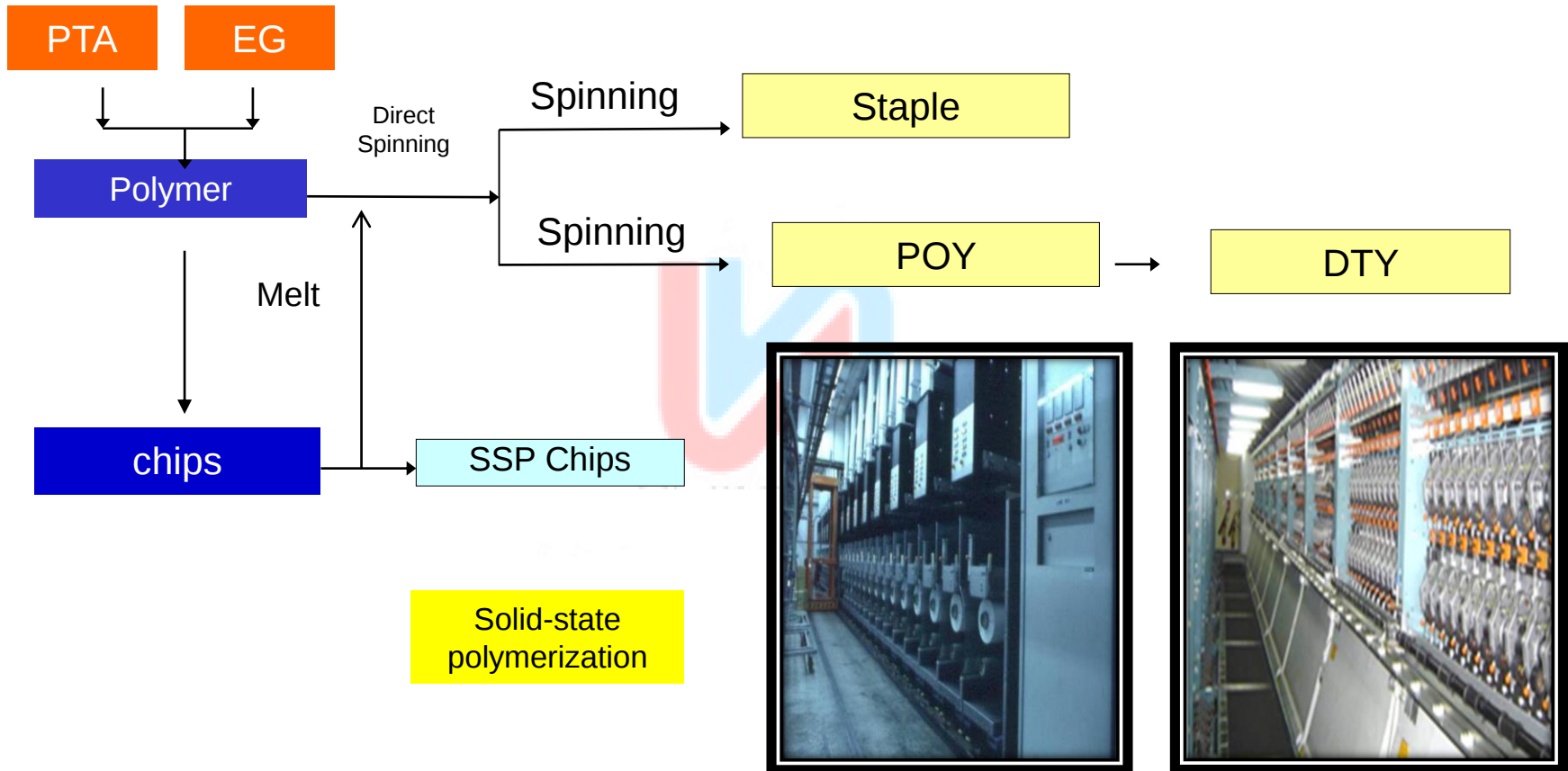

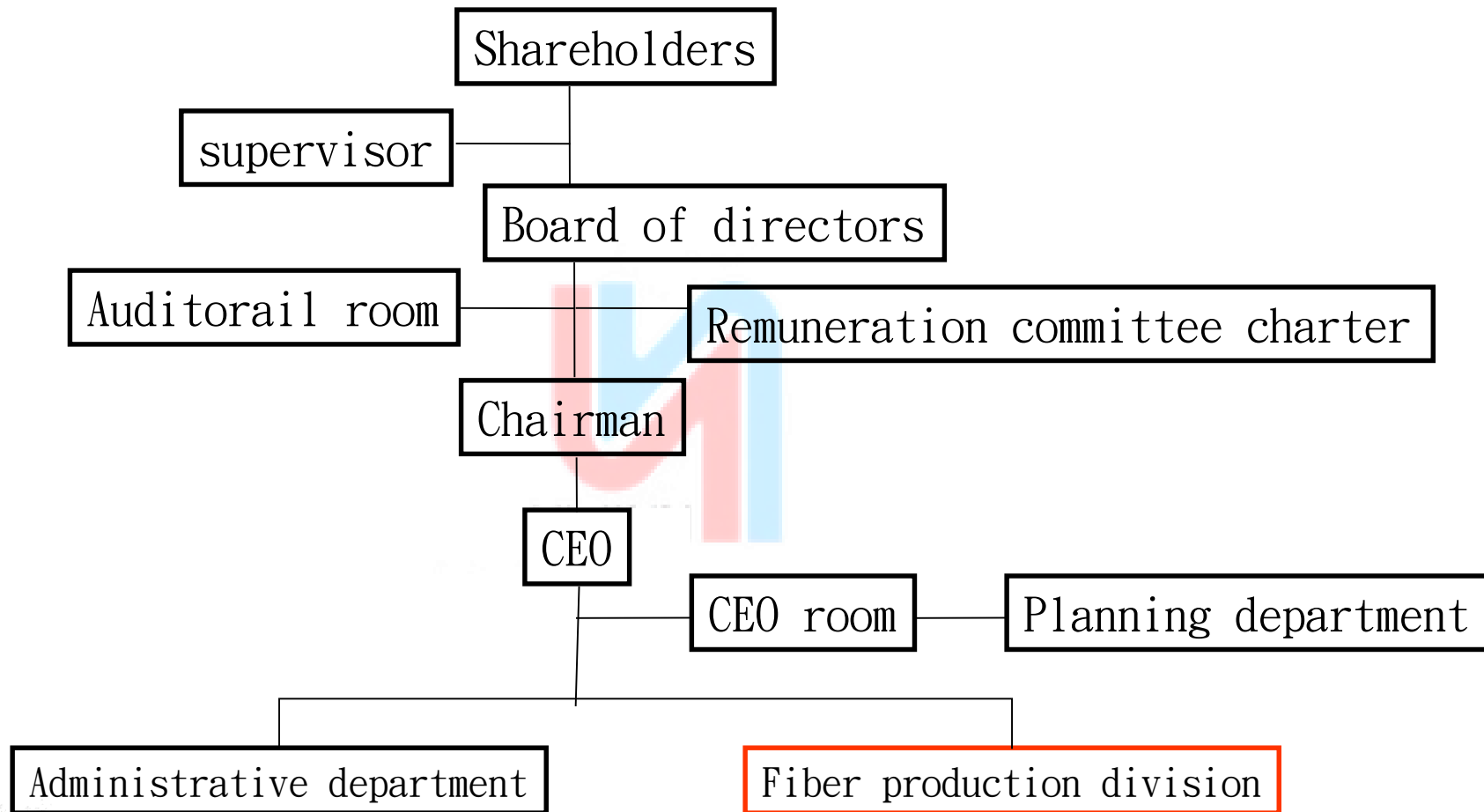




Introduction of Kwang Ming

- Expand Fiber Production Division in 2015, become upstream manufacturer. Start to produce and sale DTY
- Capital : NTD400 million
- Revenue in 2020 : NTD590 million
- Revenue in 2021 : NTD920 million
- **Revenue in 2022 : NTD930 million**

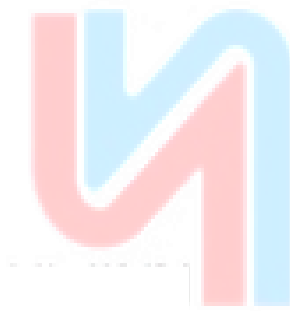
