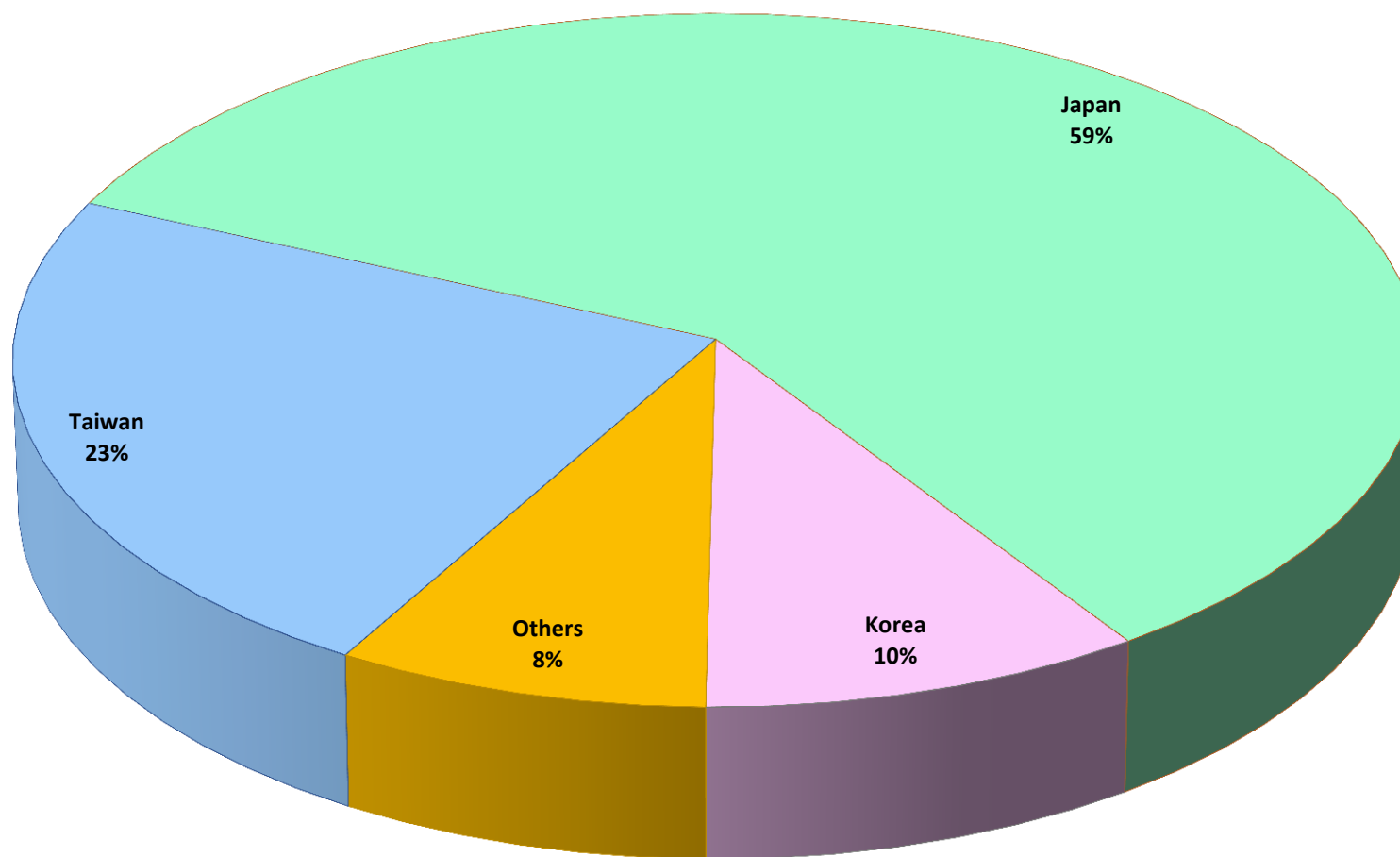
Company History

1989	Shares publicly listed on the Taiwan Stock Exchange.
2005	Sold plant machinery and equipment, transferred to triangular trade and plant, real estate rental business.

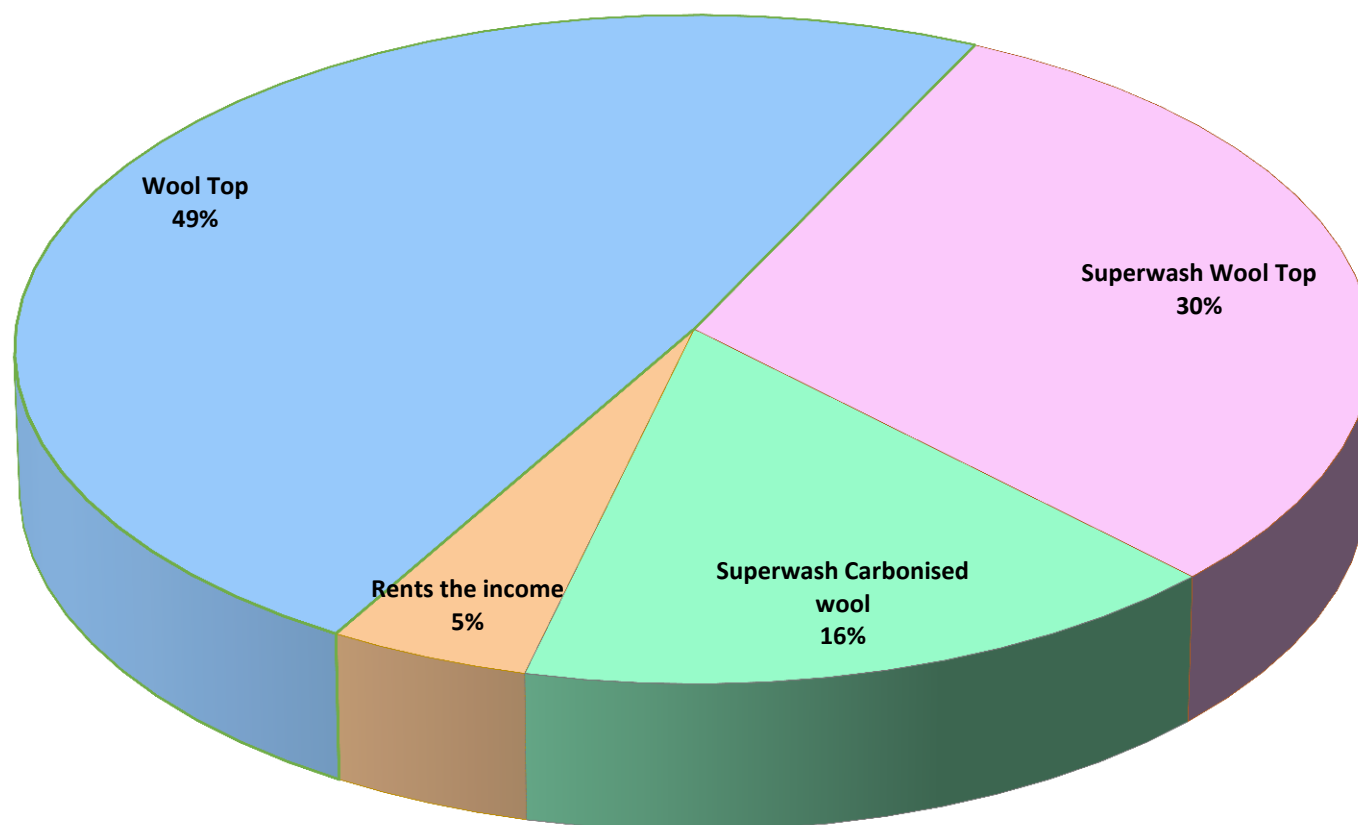
Main products

- ◎Selling wool tops and superwash wool tops by triangular trade and selling superwash carbonized wool by import production directly.

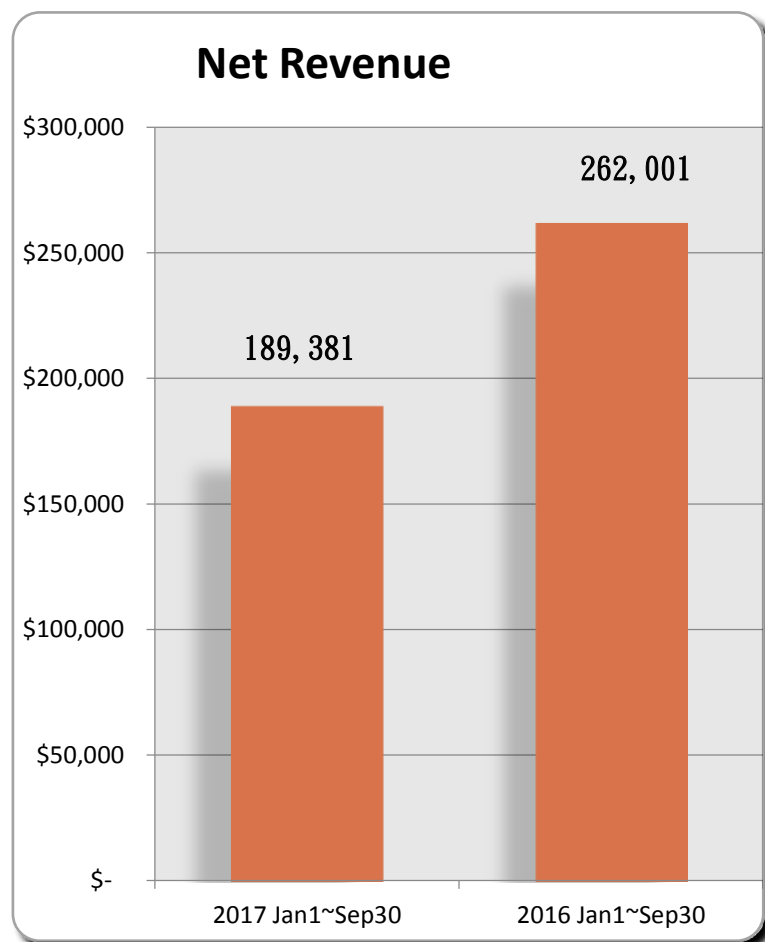
Market Distribution : 2016



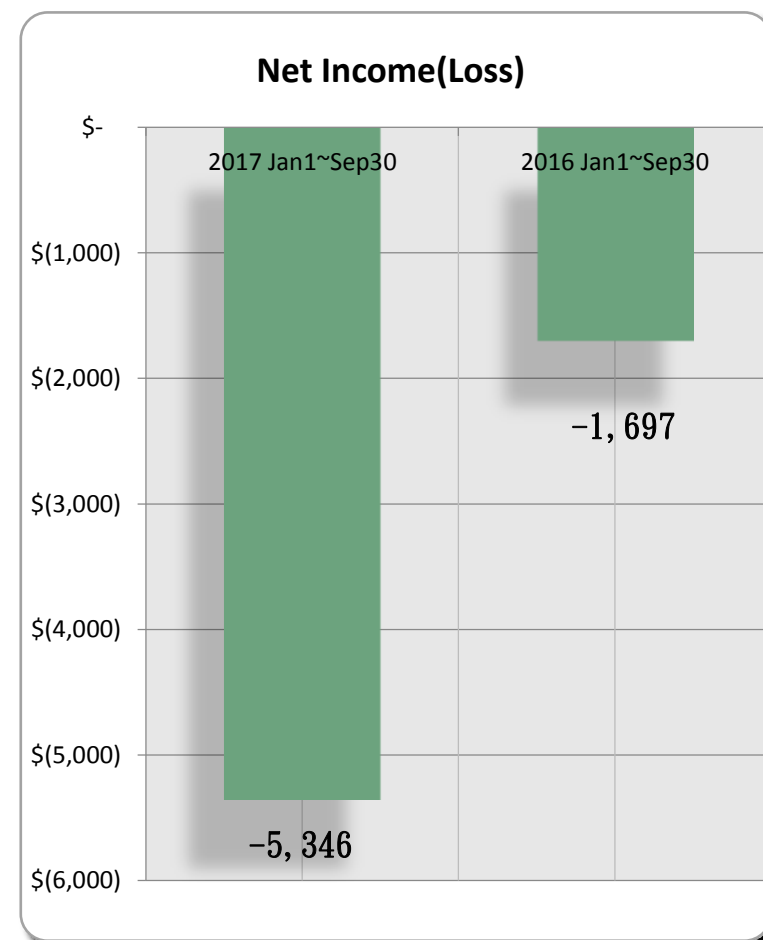
Revenue Ratio : 2016
