

INSTRUCTIONS FOR COMPLETION OF PROXY FORM

- 1. Every holder has the right to appoint some other person(s) of their choice, who need not be a shareholder as their proxy to exercise all or any of their rights, to attend, speak and vote on their behalf at the meeting. If you wish to appoint a person other than the Chair, delete the words 'the Chair of the Meeting' and please insert the name of your chosen proxy holder in the space provided. Please initial the amendment. If the proxy is being appointed in relation to less than your full voting entitlement, please enter in the box next to the proxy holder's name (see reverse) the number of shares in relation to which they are authorised to act as your proxy. If left blank your proxy will be deemed to be authorised in respect of your full voting entitlement (or if this proxy form has been issued in respect of a designated account).
- 2. To appoint more than one proxy, an additional proxy form(s) may be obtained by contacting the Registrar or you may photocopy this form. Please indicate in the box next to the proxy holder's name the number of shares in relation to which they are authorised to act as your proxy. Please also indicate by ticking the box provided if the proxy instruction is one of multiple instructions being given. All forms must be signed and should be returned together in the same envelope.
- 3. Your proxy will vote or abstain from voting as they think fit on any other business which may properly come before the GM. If you tick 'against' your vote will not be counted in computing the required majority. If you tick 'vote withheld' for any resolution you are directing your proxy not to vote and your votes will not be counted in computing the required majority or total votes cast.
- 4. In the case of joint shareholders, any of the shareholders may vote in respect of their holdings but, where more than one is present at the GM, only the first-named in the share register present at the GM in person or by proxy shall be entitled to vote.
- In the case of a corporation this form must be executed under its common seal or be signed on its behalf by an attorney or a duly authorised officer of the corporation.

- To be effective, this form should be completed and returned so as to reach Equiniti Limited at the address given below not later than 48 hours before the time appointed for the GM or any adjourned GM (excluding non-working days).
- 7. If this form of proxy is executed under a power of attorney, the power of attorney or authority under which it is signed, or a notarially certified copy of such power or authority, must be deposited at Equiniti Limited at the address given below, together with this form of proxy.
- 8. To appoint a proxy electronically ('EPA') log into the Company's Registrars' online portfolio service, Shareview. You can submit your proxy by logging on to your portfolio at www.shareview.co.uk using your usual user ID and password. Once logged in simply click 'View' on the 'My Investments' page, click on the link to vote then follow the on screen instructions. EPA will not be valid if received after 9.00 a.m. on 25 November 2025 or if the GM is adjourned, 48 hours before the time for holding the adjourned GM (excluding non-working days), and will not be accepted if found to contain a computer virus.
- 9. If you hold shares through CREST you may, if you wish, register your proxy appointment electronically using the CREST electronic proxy appointment service. A proxy appointment made electronically will not be valid if sent to any address other than that provided or if received after 9.00 a.m. on 25 November 2025. For details on how to use the CREST service please refer to the Notice of General Meeting. Please note that any electronic communication found to contain a computer virus will not be accepted.
- 10. Pursuant to regulation 41 of the Uncertificated Securities Regulations 2001, entitlement to attend and vote at the meeting and the number of votes which may be cast will be determined by reference to the Register of Members of the Company at 6.30 p.m. on the day which is two working days before the day of the meeting. Changes to entries on the Register of Members after that time shall be disregarded in determining the rights of any person to attend and vote at the meeting.
