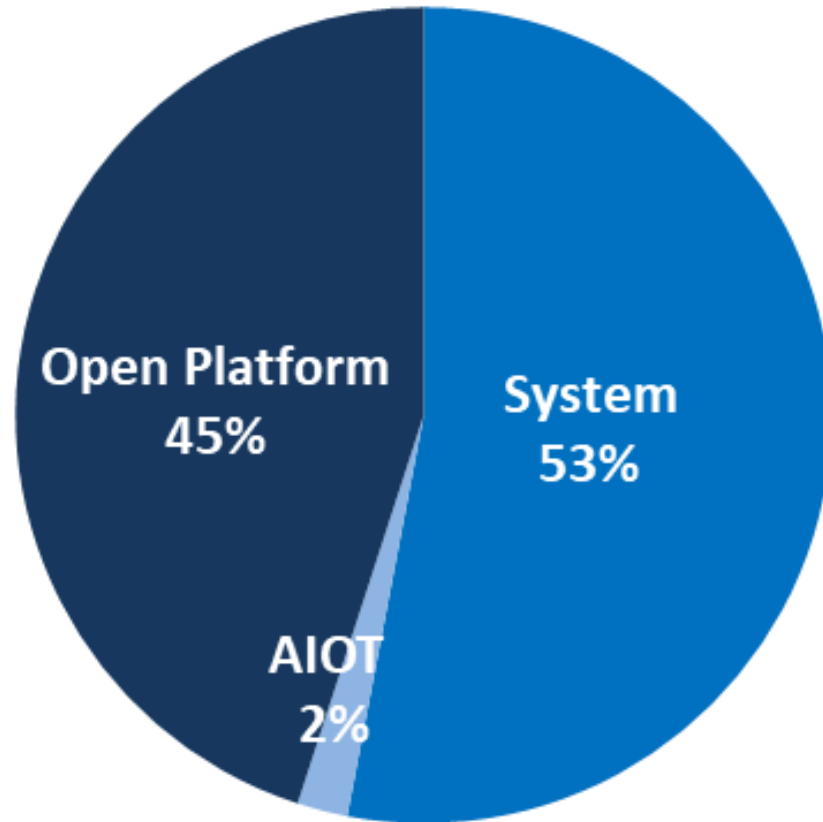

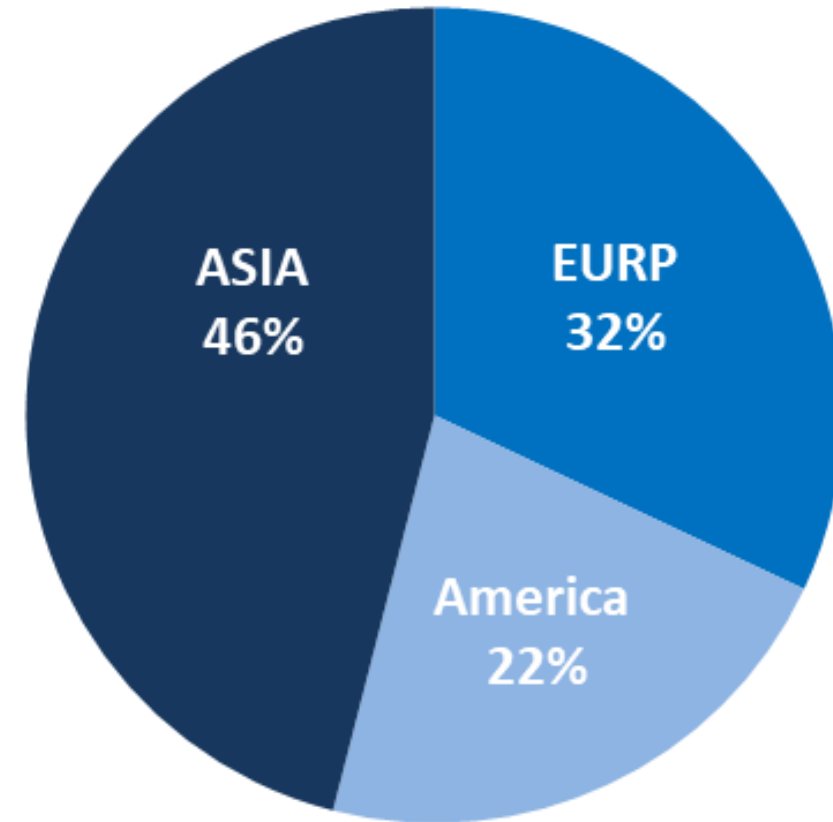

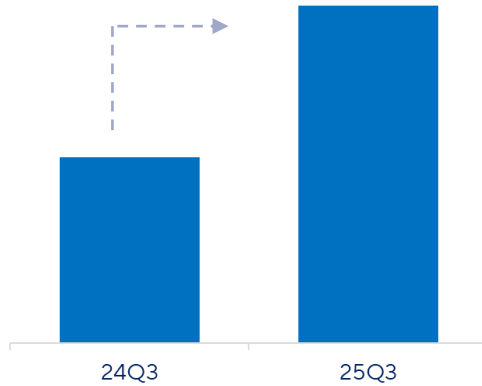

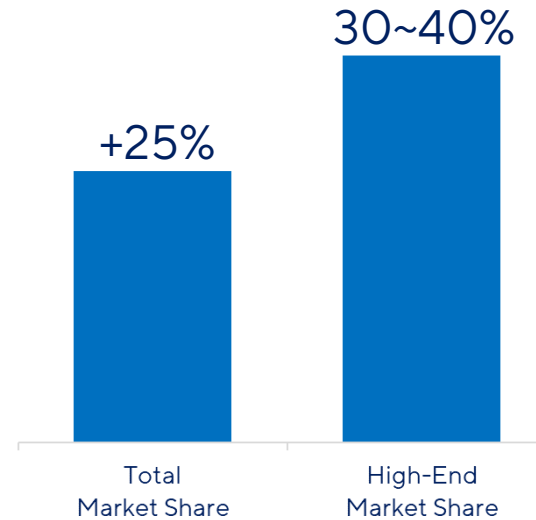

2025 Q3 Performance

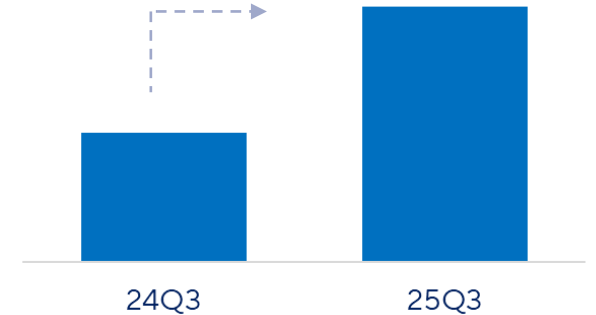
Copilot+ PC Q3 Revenue

+ 50% YoY



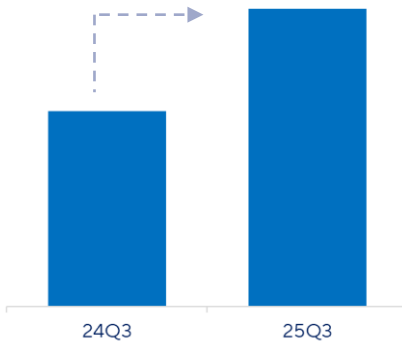

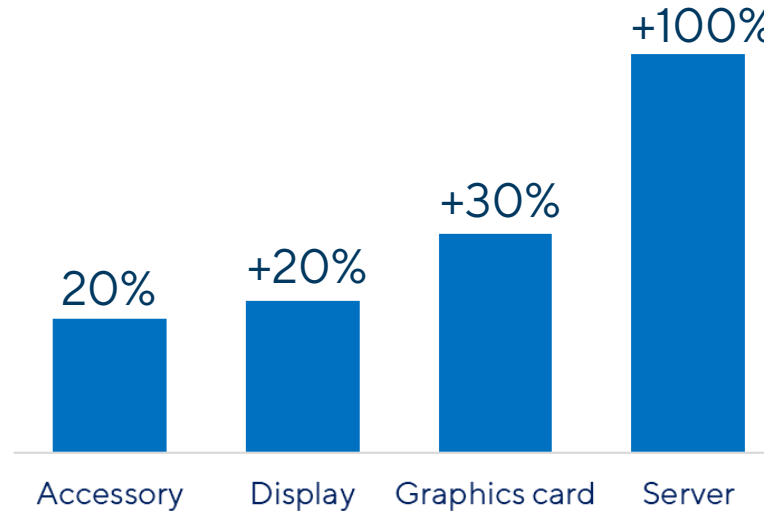

2025 Q3 Performance

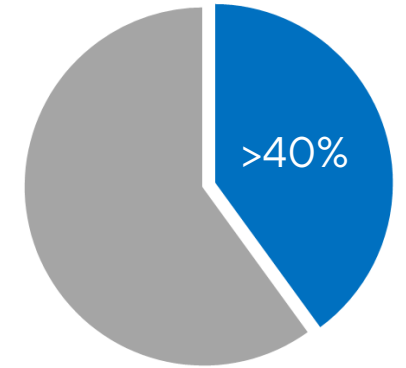

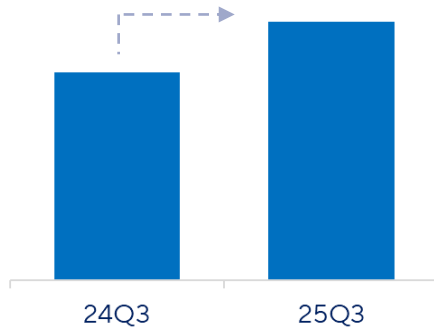

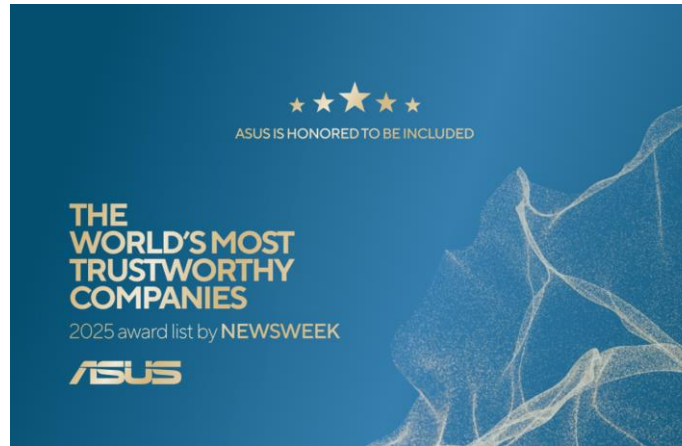
