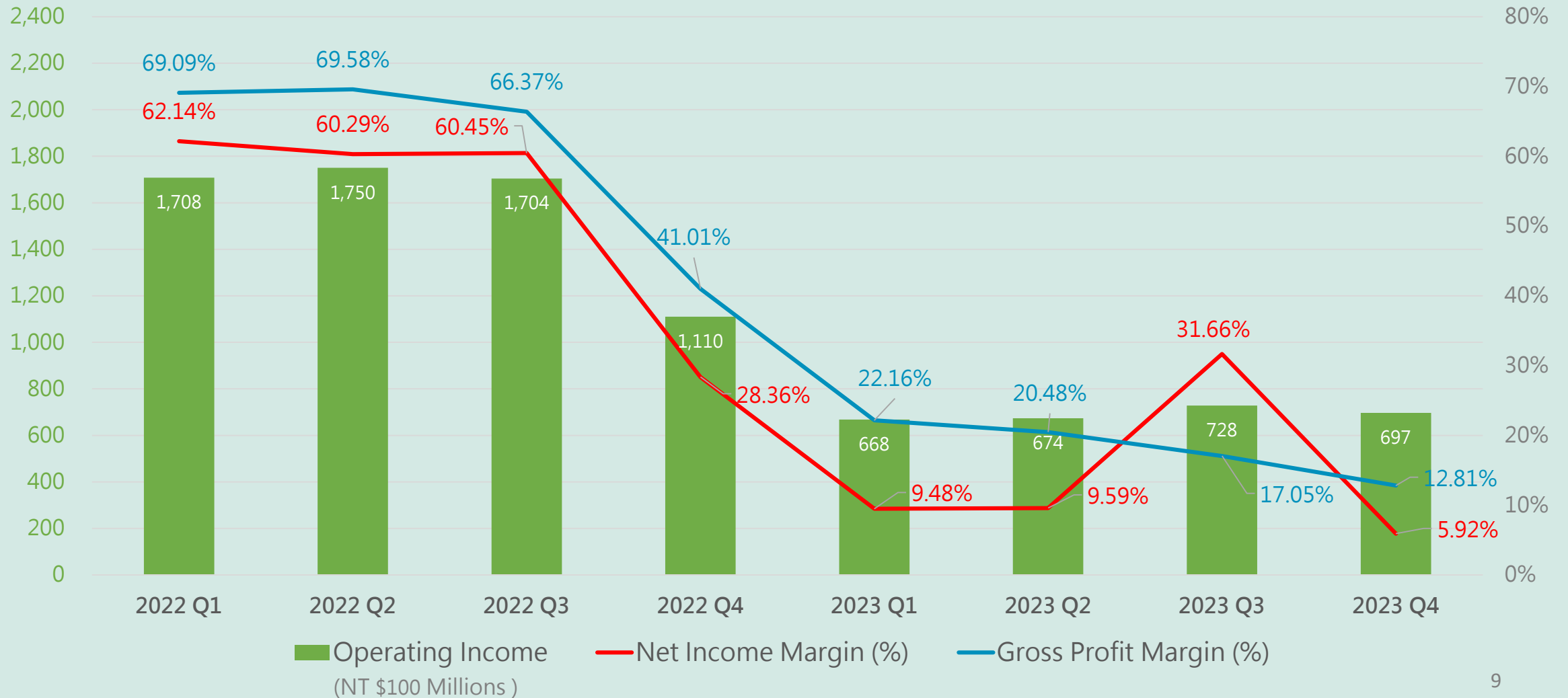

Quarterly Consolidated Operating Income, Gross Profit Margin and Net Income Margin

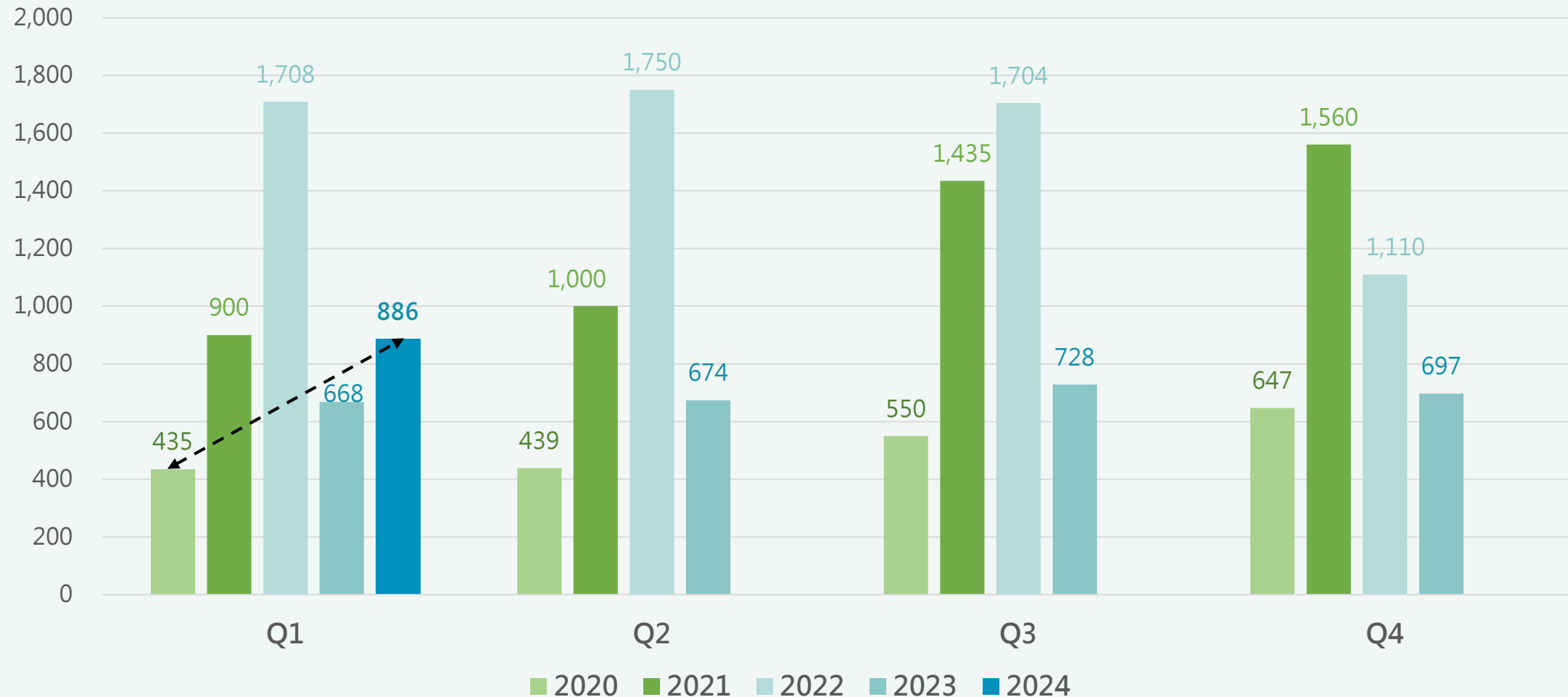

(NT \$100 Millions)

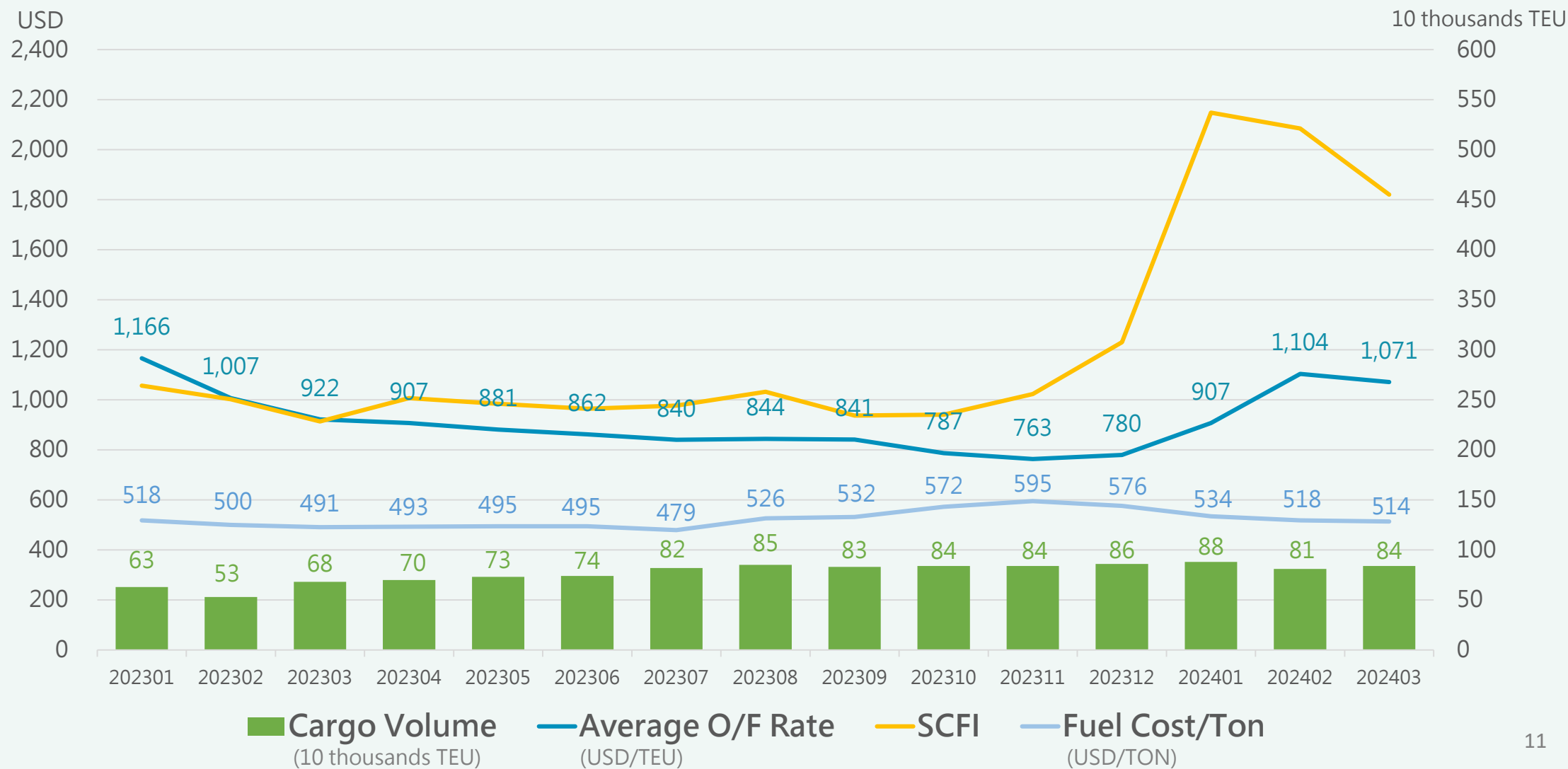

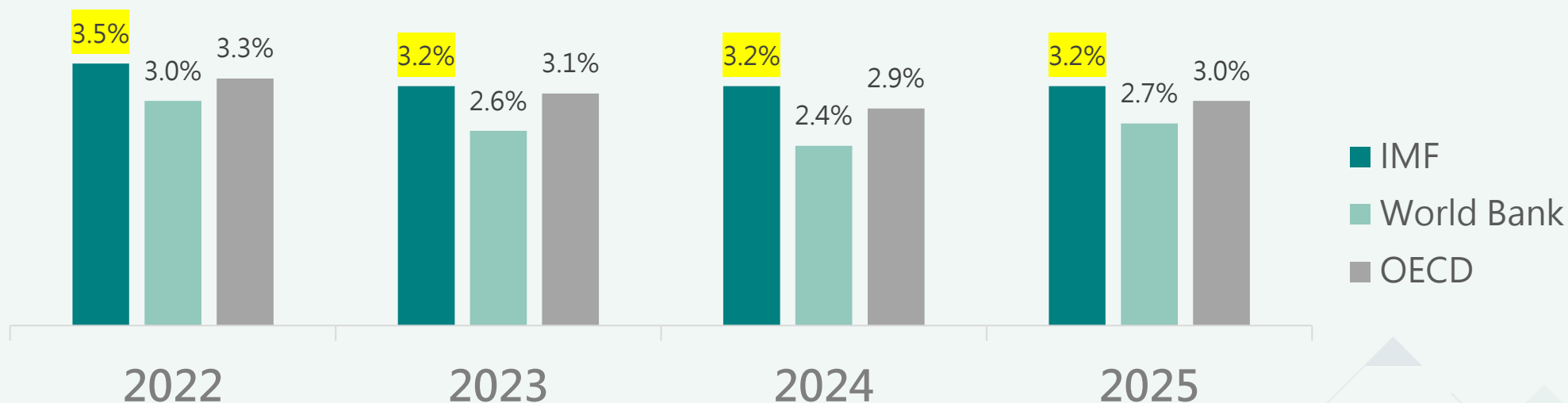

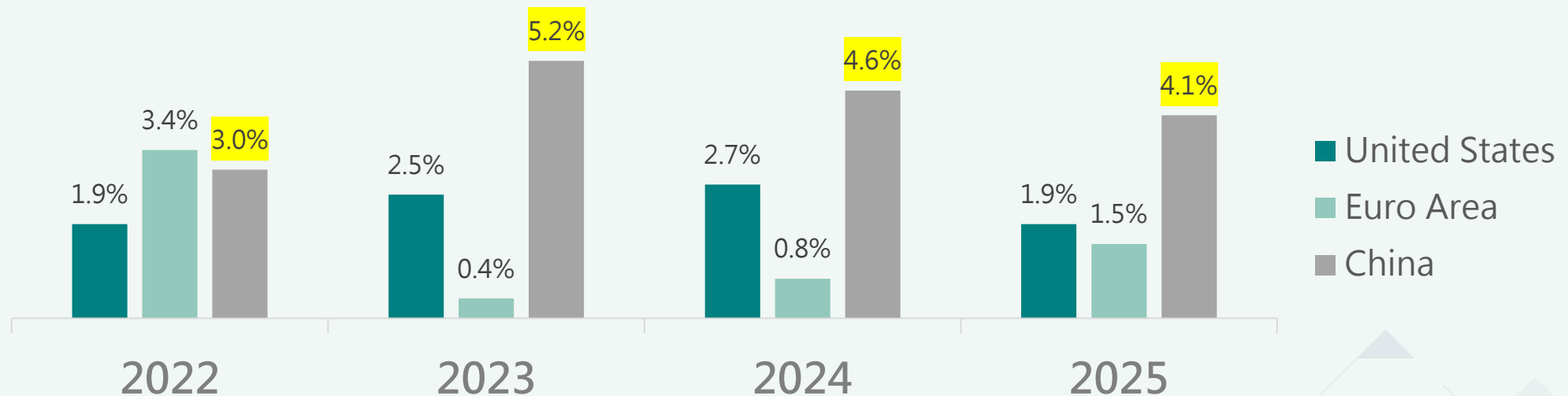
Real Gross Domestic Product Growth Forecast

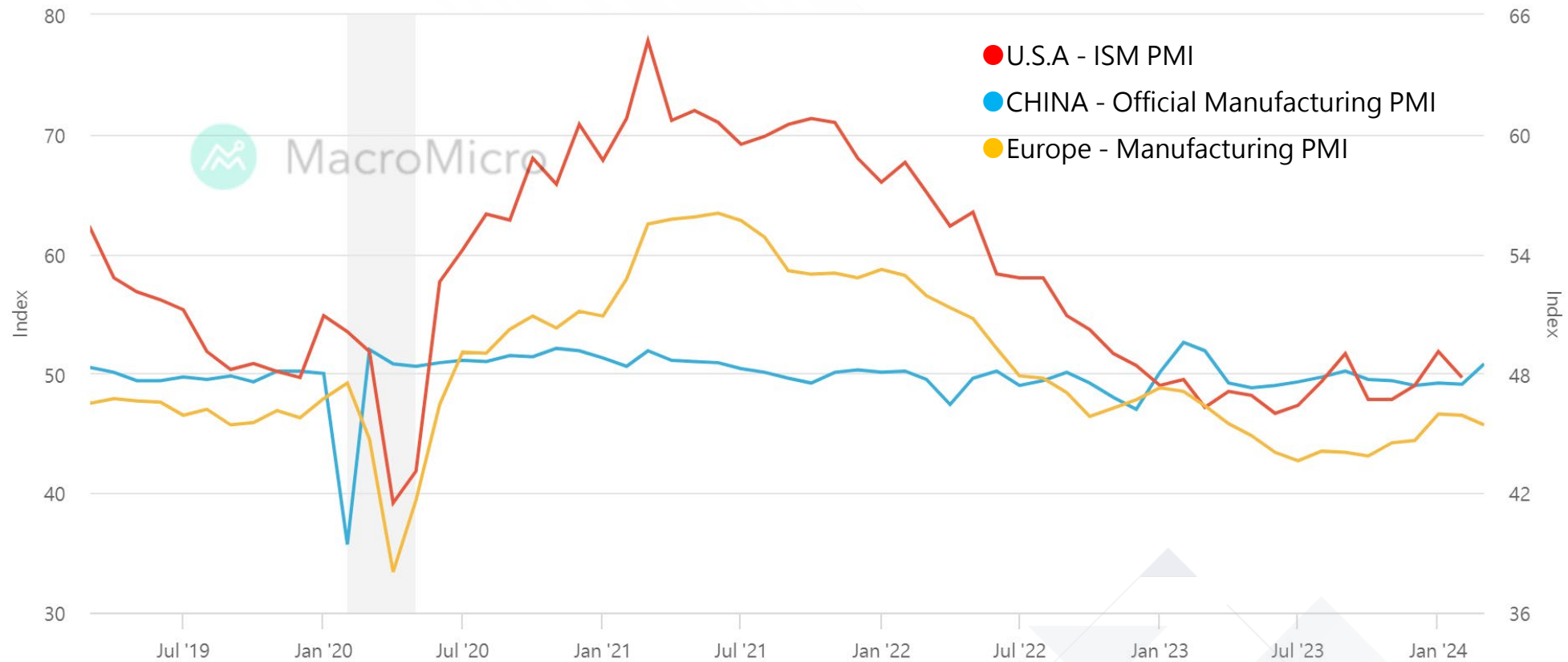
Major Economies Economic Outlook Slow but Positive

Major Economies Purchasing Managers' Index (PMI)

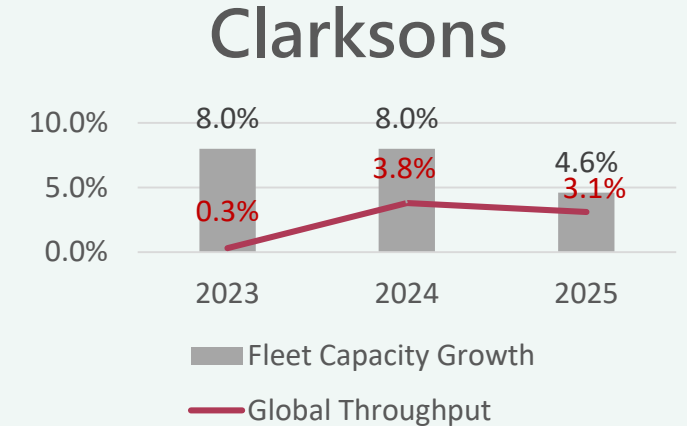
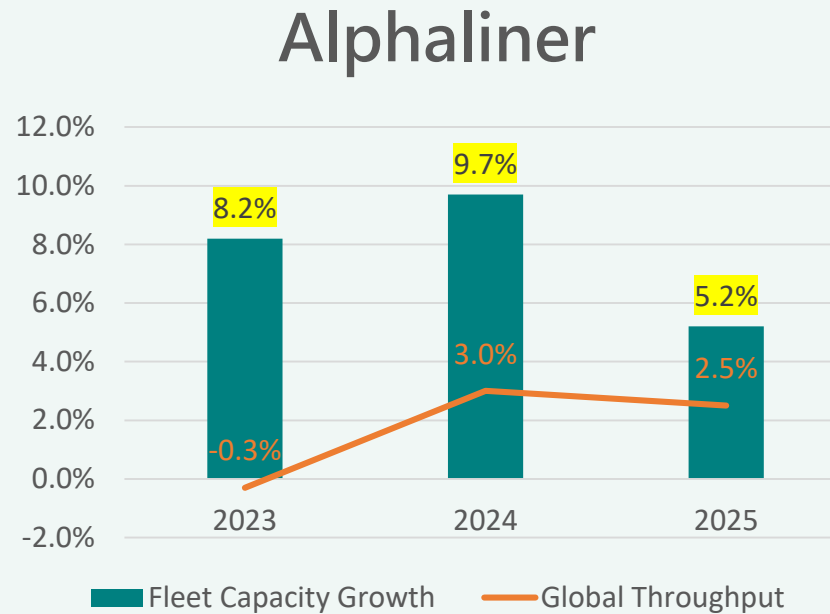
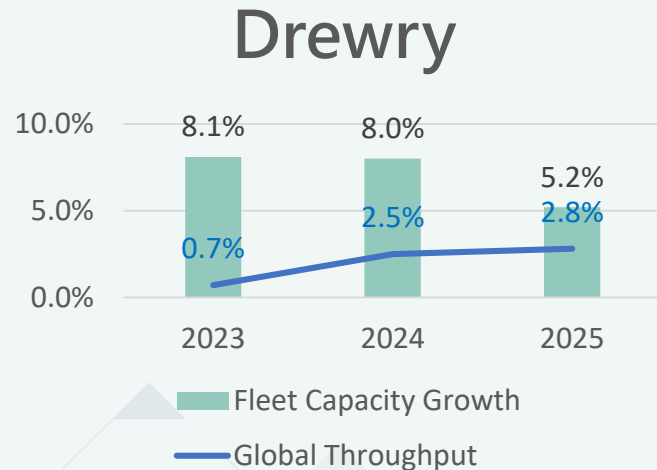

Shipping Market's Supply and Demand

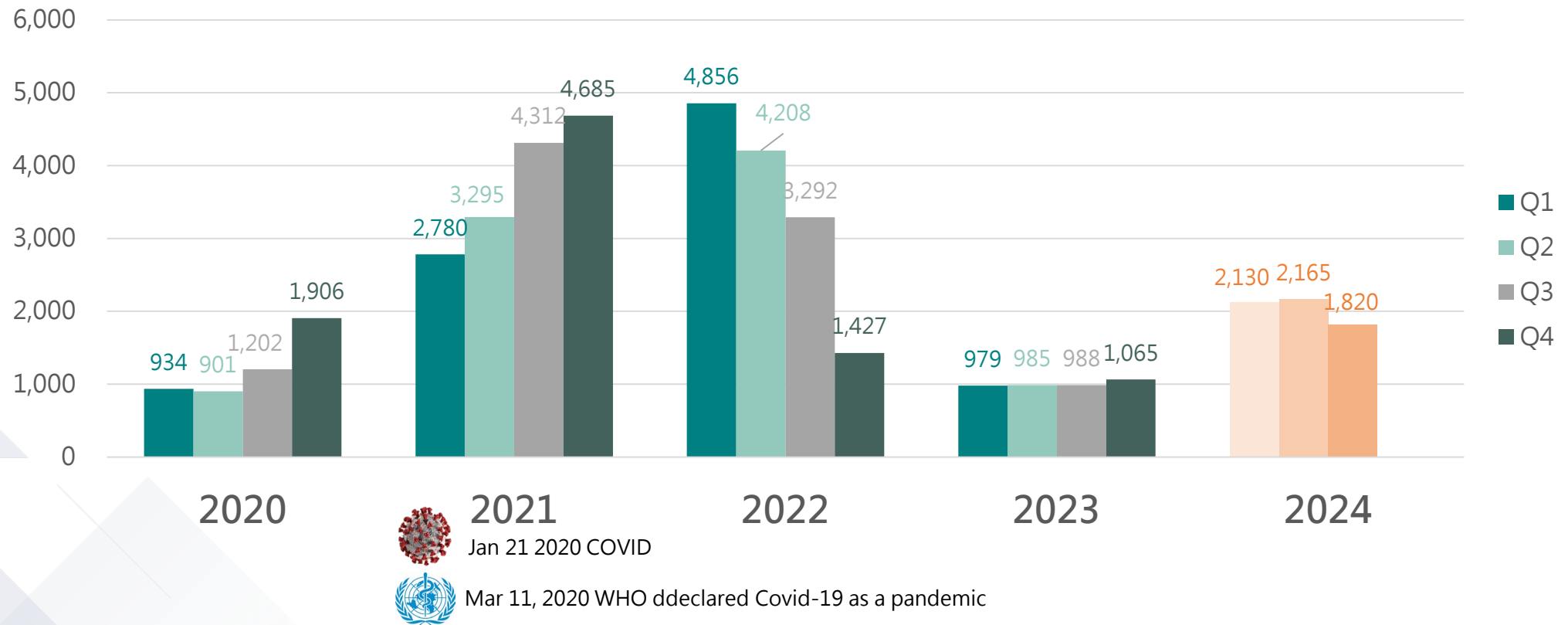

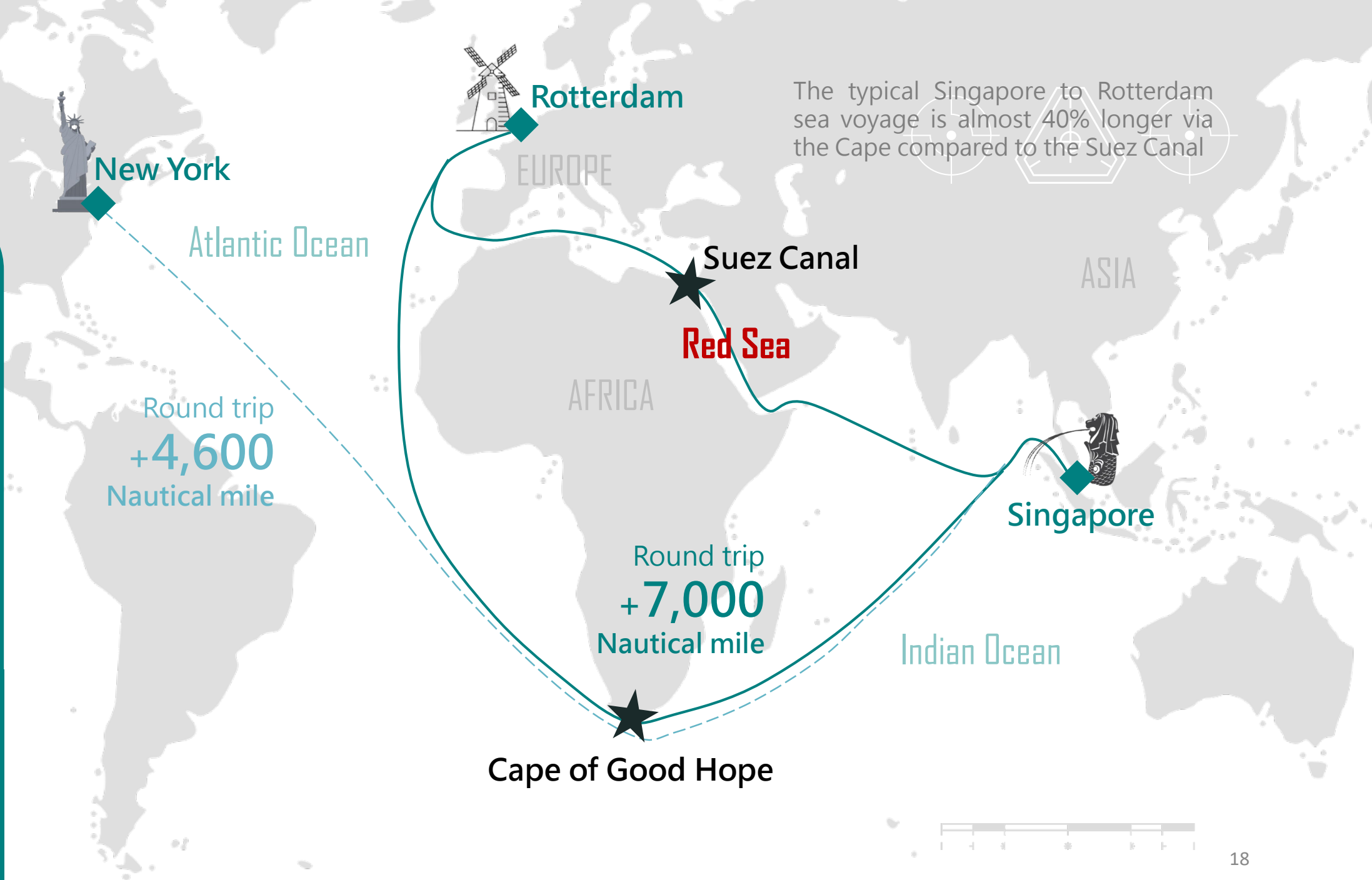
Containerized Freight Index

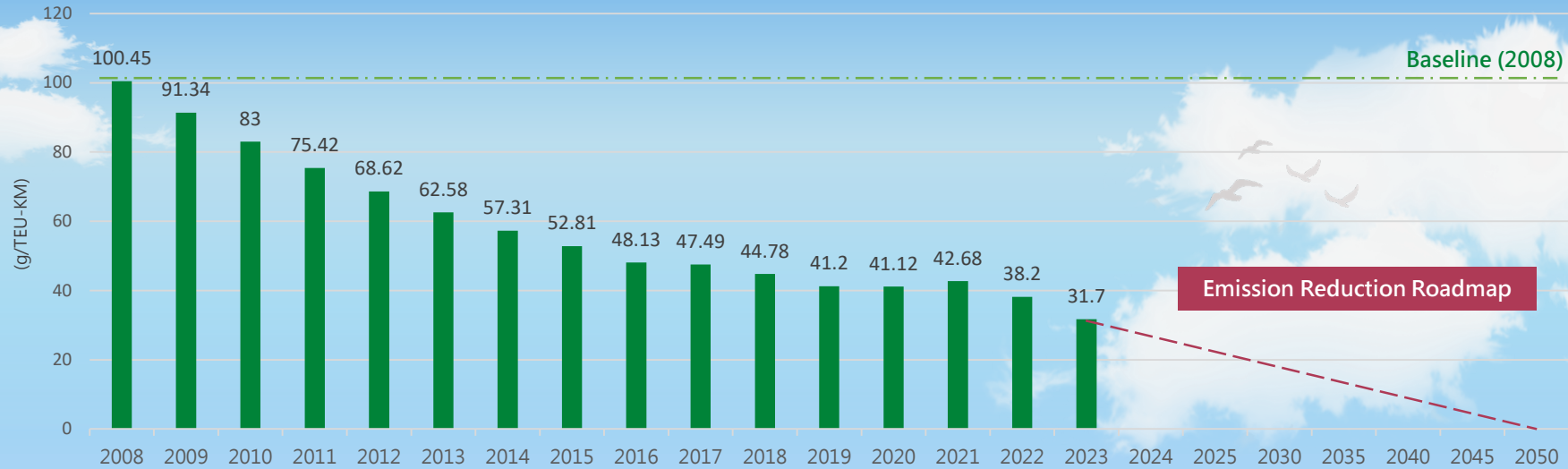

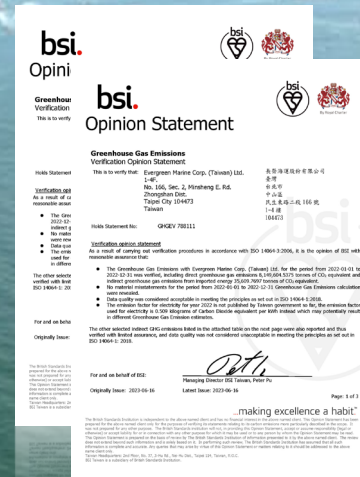
