General Meeting voting results

Ferrexpo plc (LSE: FXPO) announces the result of the General Meeting that was held earlier today, the purpose of which was for shareholders to vote on the re-election of Vitalii Lisovenko as an Independent Non-executive Director of the Company (“Resolution”). As noted in the Notice of General Meeting dated 11 August 2025, in accordance with the provisions of UK Listing Rule 6.2.9R, the Resolution required approval by a majority of all shareholders voting at the meeting.

Following today’s General Meeting, the Company confirms that the Resolution was passed as an Ordinary Resolution and voted by way of a poll.
