Notice of Annual Shareholders Meeting of 2024

1. This is to inform that the annual meeting of 2024 ("**Meeting**") will be held at the Tsui-Tsan Banquet Room of Denwell Dazhi Hotel, addressed at 3F., No. 8, Zifu Rd., Zhongshan Dist., Taipei City, at 9 am on Wednesday, May 31, 2024. The Meeting accepts shareholders to register from 8:30 am, and the location of reception is the same with the meeting.
2. **Meeting agenda:**
 - (1) **Matters to report:** (i) business report of 2023, (ii) Audit Committee's review report on the financial statements of 2023; (iii) report on distribution of employees' compensation and directors' remuneration of 2023; and (iv) Report on policy regarding the compensation and remuneration of director and manager of the Company.
 - (2) **Matters to be recognized:** (i) adoption of the business report and financial statements of 2023; and (ii) adoption of the proposal for profits distribution of 2023.
 - (3) **Matters subject to discussion and election:** (i) Proposal for new share issuance through capitalization of earnings by the Company; (ii) Release of non-competition restrictions for directors of the 8th term of the Company; and (iii) Initiation of a lawsuit against the independent director Wei-Lung Chen in accordance with the law. (shareholder's proposal)
 - (4) **Extemporaneous motions.**
3. Proposal for profits distribution of 2023 has been approved by the meeting of the board of directors as follows:
 - (1) Cash dividends: NTD0.73 per share, amounting to NTD2,516,590,308 in total.
 - (2) Share dividends: NTD0.246 per share (24.6 shares distributed for per 1,000 shares), in total of 84,805,646 shares in total.
4. The entry of the shareholding into the shareholders roster will be suspended from April 2, 2024 to May 31, 2024 in accordance with Article 165 of the Company Act.
