Nominated Persons may have a right under an agreement with the registered shareholder who holds shares on their behalf to be appointed (or to have someone else appointed) as a proxy. Alternatively, if nominated persons do not have such a right, or do not wish to exercise it, they may have a right under such an agreement to give instructions to the person holding the shares as to the exercise of voting rights.
- 4. The 'Vote Withheld' option is provided to enable you to abstain on any particular resolution. However, it should be noted that a 'Vote Withheld' is not a vote in law and will not be counted in the calculation of the proportion of the votes 'For' and 'Against' a resolution. If you do not indicate on the form how your proxy is to vote or otherwise give your proxy instructions how to vote, he/she can decide whether, and how, to vote.

Entitlement to attend and vote at the meeting and the number of votes which may be cast thereat will be determined by reference to the Register of Members of the Company at close of business on 14 May 2018. Changes to entries on the register of members after that time shall be disregarded in determining the rights of any person to attend and vote at the meeting.

Of the Directors standing for re-election, Anthony Bloom is the Chairman of the Company and a Non-Executive Director, Nisan Cohen is the Chief Financial Officer, Israel Greidinger is the Deputy Chief Executive Officer, Mooky Greidinger is the Chief Executive Officer, Alicja Kornasiewicz is a Non-Executive Director and member of the Audit Committee, Dean Moore is a Non-Executive Director, the Chairman of the Remuneration Committee and a member of the Audit Committee, Scott Rosenblum is a Non-Executive Director and member of the Nomination Committee, Arni Samuelsson is a Non-Executive Director and member of the Nomination Committee, Rick Senat is a Non-Executive Director, the Senior Independent Director, the Chairman of the Nomination Committee and a member of the Remuneration Committee, and Julie Southern is a Non-Executive Director, Chair of the Audit Committee and a member of the Remuneration Committee.
