This disclosure is to reflect the fact that the voting rights held indirectly by the underlying investment management entity Standard Life Investments Limited ("SLIL") increased above a notifiable threshold due to trading on 17 August 2020. SLIL now holds the delegated voting rights to 10.02% of the shares in Energean plc. Prior to this crossing, SLIL held 9.94% of the delegated voting rights.
