Ref: SEBI Circular dated November 3, 2021

SEBI has vide the captioned circular dated November 3, 2021, as amended, mandated:

- furnishing of PAN, postal address, email address, mobile number, bank account details, specimen signature and nomination by holders of physical securities,
- freezing of folios, wherein any one of the cited document / details are not available
- any service request in respect of securities in frozen folios shall be entertained only upon registration of the aforesaid details / documents,
- payment, including dividend, only through electronic mode towards securities in frozen folios.
- From January 1, 2022, the RTAs shall not process any service requests or complaints received from the holder(s) / claimant(s), till PAN, KYC and Nomination documents/details are received.

We observe from our records that you have not furnished some of the mandatory documents/details as per the records. - b. Folios wherein any one of the aforesaid document / details are not available **on or after April 01, 2023**, shall be frozen and you will not be eligible to lodge grievance or avail service request from the RTA and not eligible for receipt of dividend in physical mode.
- c. **After December 31, 2025**, the frozen folios shall be referred by RTA/Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and or Prevention of Money Laundering Act, 2002.

The documents may be provided through In Person Verification service by RTA / self attested and dated as hard copy / digitally signed by emails.
