Release of the members of the Board of Directors with regard to the 2015 activities and accounts will be presented to the approval of our shareholders according to the provisions of Turkish Commercial Code, the Regulation, and Internal Directive of the General Assembly.

6. Determination the Usage of the 2015 Profit and Rate of Dividend to be Distributed

According to our financials for the accounting period 1 January 2015 - 31 December 2015 prepared by our Company in compliance with the Turkish Financial Reporting Standards according to the the Capital Markets Board Communiqué numbered II-14.1. and audited by DRT Bağımsız Denetim ve Serbest Muhasebeci Mali Müşavirlik Anonim Şirketi (A member firm of DELOITTE TOUCHE TOHMATSU INTERNATIONAL), Consolidated Net Profit attributed to equity holders of the parent for the period is TL **2.236.328.185,27**. The profit distribution proposal which is prepared according to our long-term strategy, capital requirements, investment and financing policies, profitability and cash position of our Company, its subsidiaries and its affiliates is presented in Appendix 1.

7. Election of the Members of the Board of Directors, Determination of Their Duty Term

There shall be election for the Board Members whose term has expired. The geneneral Assembly will determine duty term of the members of the Board of Directors.

Işın Çelebi, Nazif Can Paker and Zekeriya Yıldırım are selected as candidates for independent Board members with the resolution of our Board of Directors with the assessment and recommendation of the Corporate Governance Committee. The Capital Market Board did not reported a negative opinion for these independent board member candidates.

The CVs and declarations of independence of each independent board member candidate are attached as Appendix 2.

8. Determination of Monthly Gross Fees to be Paid to the Members of the Board of Directors

Monthly gross fees of the members of the Board of Directors will be determined according to the provisions of Turkish Commercial Code, the Regulation and Articles of Association of the Company.

9. Informing the General Assembly Regarding the Donations and Grants Made by the Company in 2015 and Determination of an Upper Limit for Donations to be Made in 2016

According to the article 6 of the Capital Markets Board Communiqué numbered II-19.1 and the article 1.3.10 of the attachment of the Communiqué numbered II-17.1, the information regarding the donations made during the year must be submitted to the General Assembly. In 2015, the amount of donations made to the Foundations and Associations is TL 80.130,07. This article is not for the approval of the General Assembly, the purpose is only to inform the General Assembly.

The upper limit of the donations to be made in 2016 will be determined by our shareholders at the General Assembly Meeting.

10. Informing the General Assembly About the Share-Buyback Program of Our Shares by Our Subsidiary EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş., Approving the Share-Buyback Program

At the meetings of the Board of Directors of H.Ö Sabancı Holding A.Ş. and its subsidiary EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş. held on December 22, 2015, it was resolved;

to buyback Sabancı Holding's outstanding shares up to 40.000.000 lot pursuant to Article 22 of Capital Markets Law and Share Buyback Communiqué (II-22.1) of CMB by our subsidiary EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş. on the Stock Exchange, considering that the share price of Sabancı Holding is not reflecting the real performance of Sabancı Holding's activities,

1) To execute buyback process in accordance with the "share buyback program" to be accepted by the Board of Directors of EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş.,

2) To buyback the shares of Sabancı Holding on the Stock Exchange by of EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş. at the price TRY 12,00 and below, if it's considered necessary,

3) To continue share buyback program until the first General Assembly of Sabancı Holding,

- 4) To inform the shareholders about operations carried out within the framework of the buyback program at the first general assembly of Sabancı Holding to be held,
- 5) To start buyback program by EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş. after the approval of the Capital Market Board in accordance with the item 6 of article 5 of the Communiqué mentioned above.

Accordingly, with the letter dated 29.12.2015, numbered 36/1655, Capital Market Board has approved the share buyback by the subsidiary EXSA Export Sanayi Mamülleri Satış ve Araştırma A.Ş. which will continue until the first General Assembly of Sabancı Holding to be held, in accordance with the item 6 of article 5 of the Share Buyback Communiqué (II-22.1) of CMB.

In accordance with the share buy-back program executed since 31 December 2015, EXSA A.Ş. has paid TL 190.470.244,00 for Hacı Ömer Sabancı Holding A.Ş.'s shares with a nominal value of TL 23.896.728,00 and purchased the shares with an average price of TL 7,97 as of 29 February 2016.

In order to continue the share buyback program approved by Capital Market Board after the General Assembly Meeting, at the meetings of the Board of Directors of H.Ö Sabancı Holding A.Ş. and its subsidiary EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş. held on February 23, 2016, it was resolved; to buyback Sabancı Holding's outstanding shares up to 40.000.000 lot, including the shares purchased with the approval of Capital Market Board dated 29.12.2015 and numbered E.144764, pursuant to Article 22 of Capital Markets Law and Share Buyback Communiqué (II-22.1) of CMB by our subsidiary EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş. on the Stock Exchange, considering that the share price of Sabancı Holding is not reflecting the real performance of Sabancı Holding's activities,

- 1) To execute buyback process in accordance with the "share buyback program" to be accepted by our General Assembly,
- 2) To present attached "Share Buyback Program" for the approval of the General Assembly at the Ordinary General Assembly Meeting,
- 3) To pursue the buyback program by EXSA Export Sanayi Mamulleri Satış ve Araştırma A.Ş. in accordance with the item 2 of article 5 of the Communiqué mentioned above.

The Share Buyback Program of H.Ö Sabancı Holding A.Ş. which is indicated above and to be presented for the approval of the General Assembly is attached as Appendix 3.

11. Election of the Auditor and Group Auditor

In line with the regulations of the Turkish Commercial Code numbered 6102 and Capital Market Law numbered 6362, with the recommendations of the Audit Committee, Our Board of Directors has resolved that, DRT Bağımsız Denetim ve Serbest Mali Muhasebeci Mali Müşavirlik Anonim Şirketi (A member firm of Deloitte Touche Tohmatsu Limited) is elected to audit Financial Reports for the 2016 accounting period, to be Group Auditor, and to carry out other activities according to the regulations in the related laws, and this decision will be presented to the approval of the General Assembly.

12. Granting Permission to the Chairman and Members of the Board of Directors for the Activities Under the Articles 395 and 396 of the Turkish Commercial Code.

The members of our Board of Directors can do business as stipulated in the 1st subsection of 395th and 396th articles of Turkish Commercial Code entitled "Ban to Enter into Business with the Company and Borrowing" and "Competition Ban" only with the approval of the general assembly. In order to fulfill the necessity of these regulations, the granting of this permission shall be presented to our shareholders' approval at the General Assembly meeting and the information shall be given for these kind of transactions has been realized during the year.

- ç) I will not to be a full time employee at public authorities and institutions after being elected, except being an academic member at university provided that is in compliance with the relevant legislation,
