The summarized results for the revised annual accounts, standalone and consolidated, for the year ended 31st March, 2015 are enclosed herewith.

The Board of Directors of the Company at their meeting held today also recommended payment of dividend of Rs. 3 (Rupees Three Only) per equity share of Re.1/- each of the Company for the year ended 31st March, 2015, subject to the approval of the members at the ensuing Annual General Meeting of the Company to be held in around end of October 2015.
