Subject: Clarification on speculative news / rumours in respect of search operations at Refex Group by the Income-Tax Department

This is in continuation to our earlier disclosure dated December 12, 2025 titled "*Clarification to a reported event or information circulated in the electronic media*" and subsequent intimation dated December 14, 2025 titled "*Closure of search operations at Refex Group by the Income-Tax Department*". Some of the media reports referenced an alleged press release or statement by the Income-Tax Department, which formed the basis of such media reports.

We would like to inform all our stakeholders that an offline application was filed under the Right to Information Act, 2005 ("**RTI Act**") seeking information from the Income Tax Department to confirm whether there were any press release(s), official statement(s), press communication(s) or public communications(s) issued by the Income-Tax Department in connection with the search and seizure operations conducted at Refex group of companies/ entities for the period from December 09, 2025 to December 13, 2025.

As per the Order passed under Section 7(1) of the RTI Act by the ITO (HQ) (Inv)/DGIT (Inv) dated February 10, 2026, received by the applicant on February 18, 2026 (*copy enclosed herewith*), it has been confirmed by the Income Tax Department that there was '**No**' press release(s), official statement(s), press communication(s) or public communications(s) issued by the Income-Tax Department in connection with the outcome of search and seizure operations conducted at Refex group of companies/ entities for the period from December 09, 2025 to December 13, 2025.

The Company shall keep the Stock Exchanges informed of any material development, if any, in accordance with the applicable provisions of the SEBI Listing Regulations.
