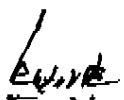

**Press Release****Simplex Infrastructures Limited****Simplex Infra announces FY14 results**

Kolkata, May 30, 2014 – Simplex Infra has announced its audited Results for the Year ended March'14.

The Company has achieved during the FY14 a Standalone Gross Sales of ₹ 5615 crs a tad lower than ₹ 5921 crs last year. On the lower sales, EBITDA rose by 9% to ₹ 636 cr (₹ 586 cr) and EBIT by 12% to ₹ 432 cr (₹ 386 cr). However due to higher interest cost PBT is lower at ₹ 86 cr against ₹ 90 cr and PAT ₹ 61 cr as against ₹ 60 cr.

During the Q4 the Company achieved a topline of ₹ 1463 cr, EBITDA ₹ 167 cr, EBIT ₹ 115 cr, PBT ₹ 22 cr and PAT ₹ 21 cr.

The Consolidated Gross Sales for FY14 stands at ₹ 5723 crs as against ₹ 5999 crs last year. The consolidated EBITDA for FY14 is ₹ 643 crs. EBIT ₹ 433, PBT ₹ 86 and PAT ₹ 58 crs.

The order intake during the 4th Quarter is ₹ 964 crs and cumulative order inflow during FY14 is ₹ 7876 crs. The order book as of March'14 stands at ₹ 15257 crs in addition to the LI status of ₹ 936 cr.

Board has recommended a dividend of ₹ 0.50 per equity share of face value of ₹ 2/- each for the year ended 31.03.2014.
