Pursuant to Para B Part A of the Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, we wish to inform you that, in order to prevent the spread of Novel Corona Virus (COVID 19) outbreak, the Company has complied with various directives issued by Central/State/Municipal authorities including work from home and ensuring continuous supplies of basic packaging materials used by pharmaceutical and FMCG industries.

In view of the country-wide lockdown, the operations at several of our manufacturing plants, offices, warehouses, depots are impacted/scaled down. As Company's products being considered as an essential commodity for other industries, we are operating some of our plants amidst all constraints after taking adequate approval of local authorities and steps to ensure the safety and health of our employees.

Keeping in mind that the lockdown has affected the entire supply chain and coupled with the uncertainty regarding resumption of normal operations, the overall adverse impact on the operations of the Company is not immediately assessable.

We will continue to monitor the situation and shall take all appropriate steps, as per regulatory directives of the Central/State /local authorities.
