Nanhe Fariste campaign was launched for children in 2018

Vadodara, The Railway Police (RPF) launched the 'Nanhe Farishte' campaign in 2018 to find children under the age of 18 who were found abandoned at railway stations and safely return them to their parents. Under the campaign, 143 children, including 90 boys and 53 girls, have been rescued from Ahmedabad

station in 16 months. These children have been returned to their parents by the city's NGO, Prayas Sanstha. The official said that along with the security of trains and passengers at the station, the RPF also carries out other responsibilities, including scolding children at school or at home for studying, often

leading to them running away from home and reaching other cities by train. Similarly, when the economic condition of the family is not good, children run away from home in the temptation of earning money with other friends. This campaign is being run to find children who are often kidnapped or separated while traveling.

Car rams into ST bus with explosives

The employees working as Sharanai players at the Balaji temple in Gandhidham, Kutch, were on their way to Dwarka for darshan. In the accident, 53-year-old Ramanuja Jagannath Panchangam Charul died on the spot. While 67-year-old Kasaiya Ramulu Rompli died during treatment at Morbi Civil Hospital.

The car's drivers, Krunal Prakashbhai Ashwini, Ajnar Lachchut, and Dhalaiya Krishnamurthy Naviri, have been shifted to hospitals in Morbi and Rajkot for treatment due to serious injuries. The 13-year-old child in the car was not injured.

Morbi Taluka Police have reached the spot and started

investigation. Beat Jamadar M.P. Zala has conducted the primary investigation and PSI A.B. Mishra is conducting further investigation. The CCTV video of the accident has gone viral on social media. Shocking CCTV footage of the attack in Vapi

One trampled a youth and the other hit him with a heavy stone more than 10 times, leaving him half dead

Valsad In Vapi, two youths thrashed a man with a stone in public over a minor dispute. One trampled the youth and the other pelted him with a stone more than 10 times, leaving him half dead. The shocking scenes of the attack in public were also captured on CCTV. The youth sustained serious injuries in the attack. He has been shifted to the hospital for treatment. On the other hand, the police have arrested both the accused.

Two men attacked with stones

If we look at the entire incident in detail, an incident of attack on a youth came to light on Thursday evening in the Moti Sulpad area of Vapi city in Valsad district. Two men attacked 23-year-old Anmol Anil Sharma with stones, who was going towards Bihari Nagar.

The youth sustained serious injuries to his body, including his hands and feet. Anmol lives in Yogeshbhai's flat in Moti Sulpad, Vapi. Accused Praveen Bhikhu Patel and Chetan Patel caught Anmol from behind after meeting him in the ground. Both the accused attacked Anmol. One person trampled the youth. While the other person attacked him on the body with a stone. He hit him with a stone more than 10 times one after the other. Anmol suffered serious injuries to his body, including his hands and feet, in the attack. It has been found that one leg is fractured.

The seriously injured young man was taken to the hospital for treatment.

The police arrested both the accused

and the injured Anmol has been admitted to Valsad Civil Hospital for treatment. A complaint has been registered against both the accused at Vapi Town Police Station. As an immediate step in this incident, the Vapi Town Police registered a case under Sections 115(2), 117(2), 118(2), 352, 351(3), 54 of the IPC on the basis of the complaint and started an investigation. The accused had absconded after the incident. To arrest them, action was taken under the guidance of Valsad District Superintendent of Police Dr. Karanraj Vaghela and DySP B.N. Dave and under the leadership of Vapi Town Police Inspector K.J. Rathod. Both the accused involved in the crime have been arrested today and legal action has been taken against them. Surat An incident has come to light in the Ichchapore area of Surat city where a 6-year-old innocent girl was raped by her own neighbor. The girl is currently undergoing treatment in the hospital, while the accused has absconded. The Ichchapore police have formed five different teams to nab the accused Jai Mangal and have checked more than 50 CCTV footages. The accused took the girl to his house.

Son-in-law lashes uncle-in-law 19 times with wooden stick

Kanha Builder Group MD fatally attacked with 9 men in Vadodara, beat him up and threw away his bicycle

Vadodara Dhaval Thakkar, MD of Kanha Builder Group in Vadodara, went to his uncle-in-law's house with 8 to 9 people. Where he beat his uncle-in-law 19 times with a wooden stick one after the other. In addition, he also threw a loose bicycle at him. However, the entire incident was captured on CCTV. In the fatal attack by his son-in-



law, the uncle-in-law was injured and was rushed to Sayaji Hospital in a serious

condition. A police complaint has been registered against Dhaval Thakkar at Chhani Police Station in this matter. Chhani Police has formed teams and started searching for the accused Dhaval Thakkar. Jagdishbhai Rasiklal Thakkar, originally residing in Krishnakunj Society on Shakkarpur Road in Khambhat and currently residing.

કાર સીઝ કરવા આવેલા માથાભારે લોકોએ કરેલા હુમલામાં ત્રણને ઈજા

અમદાવાદ, અમદાવાદ શહેરના આનંદનગર હરણ સર્કલ પાસે આવેલી લક્ષ્મીકૃપા સોસાયટીમાં રહેતા એક વ્યક્તિએ નાણાંની યુકવણી ન થતા દ્રાવેલ્સના માલિક દ્વારા એક કાર આપવામાં આવી હતી. જે કારના હપતા મુજબ માલિક દ્વારા બેંકમાં જમા ન કરાતતા રીકવરી એજન્સીનો સ્ટાર્ટ કાર સીઝ કરવા માટે આવ્યો હતો. જ્યાં તેણે યુવક અને તેના ત્રણ સગા પર જીવલેણ હુમલો કર્યો હતો. જેમાં ગંભીર ઈજા થતા આનંદનગર પોલીસે ગુનો નોંધીને કાર્યવાહી હાથ ધરી છે. આનંદનગર હરણ સર્કલ પાસે

ત્યારે દિલીપ રાવલે અન્ય ત્રણ માથાભારે લોકોને બોલાવીને લાકડી, છરી વડે હુમલો કર્યો હતો. જેમાં ત્રણ લોકોને ગંભીર ઈજા પહોંચી હતી. એટલું જ રીકવરી એજન્સીના માણસોએ નવીન અને તેના સગાના

વાહનોમાં તોડફોડ પણ કરી હતી. આ અંગે આનંદનગર પોલીસે ગુનો નોંધીને કાર્યવાહી હાથ ધરી છે.
