Enclosed is a disclosure made by CTL Trusteeship Limited under Regulation 29 (1) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (the "**Takeover Code**").

A debenture trust deed dated June 25, 2026, as amended from time to time ("**Debenture Trust Deed**") has been entered into between, *inter alia*, OSS Software Solutions Labs Private Limited (*as issuer*) ("**Issuer**") and CTL Trusteeship Limited ("**Debenture Trustee**") for the purpose of issuance of debentures by the Issuer ("**Debentures**").

Vividhmargi Trust ("**Trust**") holds 2,53,17,620 equity shares, constituting 27.49% of the issued and paid-up share capital as well as the total diluted share/ voting capital of Themis Medicare Limited (the "**Target Company**") ("**Shares**"). The shares in Target owned by the Vividhmargi Trust are held in the name of the trustees of the Trust, being Mr. Dinesh Shantilal Patel, Mrs. Jayshree Dinesh Patel and Dr. Sachin Dinesh Patel, in the records of the Target and the depository.

In connection with the Debentures, a pledge has been created by the Trust on the Shares, in favor of the Debenture Trustee, with effect from June 29, 2026.
