Declaration of the Results of voting conducted by Postal Ballot in terms of the Notice dated October 24, 2013

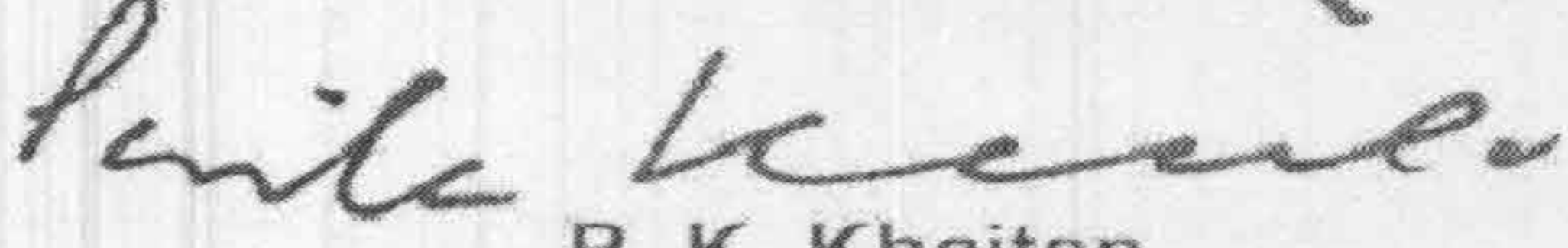
