Grant of Stock Options under the Employee Stock Option Scheme of the Bank (ESOP Scheme)

In compliance with Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements), Regulations, 2015, we hereby inform that the Compensation and Nomination & Remuneration Committee on October 23, 2024, had approved grant of 12,000 Stock Options as a pre-hiring commitment to 2 new Eligible Employees of Bank.

The main terms of the grant are mentioned below:

1. **Grant Price:** Rs. 1274.35 per share (Close Price on NSE on Tuesday, October 22, 2024, viz., previous trading day's Close Price at the Stock Exchange having the highest trading volume).
2. **Vesting Period:** 3 years from date of grant, spread at 33%, 33% and 34% at the intervals of one year from the date of grant.
3. **Exercise Period:** 5 years from date of vesting.

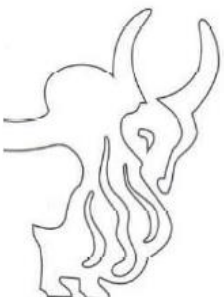
