### **Structure of Shareholders and Voting Rights**

The Company's shares are divided into groups called A, B, C and D. Each share in each group of shares can cast one vote and thus, a maximum of 350,000,000,000 (TL 3,500,000,000 equivalent) votes can be casted in the general assembly meeting. In this respect, the total number of the shares and votes owned by (i) Group A shares is 192,500,000,000 (TL 1,925,000,000.00 equivalent); (ii) Group B shares is 104,999,999,999 TL 1,049,999,999.99 equivalent; (iii) Group C share is 1 (TL 0.01 equivalent); (iv) listed Group D shares is 52,500,000,000 (TL 525,000,000.00 equivalent) respectively.

According to the article 8 of the Articles of Association; the board of directors is composed of 9 members, the Group A Shareholder shall be entitled to nominate five (5) persons for election as directors; (b) provided that the Treasury and Turkish Wealth Fund, as Group B Shareholders shall hold: – 30% or more of the shares, the Treasury shall be entitled to nominate three (3) persons for election as independent board members who carry the independence criteria as defined in the capital markets legislation; or 11 – 15% or more of the shares (but less than 30% of the shares) the Treasury shall be entitled to nominate two (2) persons for election as independent board members who carry the independence criteria as defined in the capital markets legislation; (c) As long as the Treasury and Turkish Wealth Fund holds 15% or more of the shares (but less than 30% of the shares), the Group A Shareholder shall be entitled to nominate one (1) person, who carry the independence criteria as defined in the capital markets legislation, for election as independent board members and five (5) persons for election as director. (d) while the Treasury holds the C group privileged share, the Treasury shall be entitled to nominate, a further one (1) person, for election as director for the C Group privileged share.

During the calculation of 15% and 30% of the shares of the Treasury, the amount of Group B shares and Group D shares held by the Treasury shall be taken into account together.

As well as the C Group privileged share shall be entitled to nominate a further one person for election as Director, it has below mentioned rights which are defined in the article 6 of the Articles of Association.

"For the purpose of protecting the national interest in issues of national security and the economy, the following actions and resolutions cannot be taken without the affirmative vote of the holder of the C



Group privileged share at either a meeting of the board of directors or the general assembly. Otherwise, such transactions shall be deemed invalid.

- a) any proposed amendments to the Articles of Association;
- b) the transfer of any registered shares in the Company which would result in a change in the management control of the Company;
- c) the registration of any transfer of registered shares in the Company's shareholders' ledger. "

Procedure of voting is explained in article 23 and article 24 of the Company's Articles of Association. Each share shall entitle its owner to one vote at general assembly meetings, at the general assembly meetings, voting shall be cast by raising (show) hands. However, upon the request of the shareholders owning 1/20 of the total capital represented at the general assembly meeting, voting may be realized by secret voting or by way of open ballot by calling names.

**Avni Aydın DÜREN's** and **Enver İSKURT's** appointment to the Board of Directors will be submitted to the approval of General Assembly in accordance with Article 363 of Turkish Commercial Code.

### **Enver ISKURT**

Enver İskurt was born in 1966 in Trabzon. İskurt graduated from Karadeniz Technical University, Faculty of Engineering and Architecture, Department of Construction and Anadolu University, Faculty of Public Administration. İskurt, who started working as a Survey Team Engineer at the General Directorate of Highways, Van 11th Regional Directorate in 1989, worked as a control engineer, control chief and chief



engineer respectively in the regions. After successfully carrying out his duties as the Director of the Highways Bridges Branch and the Head of the Highways Department (Head of the Department of Operations) in the General Directorate of Highways, Enver İskurt assumed the position of the Head of the Inspection Board. He is carrying out the Deputy Minister of Transport and Infrastructure duty. During his duty, he carried out the Major Repair Projects and Constructions of the 15 July Martyrs and Fatih Sultan Mehmet Suspension Bridges, took part in the projecting and construction of the Osmangazi and Yavuz Sultan Selim Suspension Bridges, which were built within the scope of BOT projects, and he has also concluded the construction tender with the project development and approval processes of the 1915 Çanakkale Suspension Bridge, which is still under construction. Avni Aydın Düren graduated from the Faculty of Law at Istanbul University and earned his graduate degree on International Law from the American University, Washington College of Law. After serving as an associate, partner and managing partner for over 18 years at international private law firms in New York, London and Istanbul, Mr. Düren joined Garanti BBVA on February 1, 2009 as Executive Vice President in charge of Legal Services. Mr. Düren has been appointed as a Board Member and Audit Committee Member on 17 June 2020. Furthermore, Mr. Düren is Vice Chairman of Garantibank International N.V. and T. Garanti Bankası A.Ş. Pension and Provident Fund Foundation, and Board Member of Garanti Payment Systems, Garanti Mortgage Consultancy Services and Board of Trustees Member of Teachers Academy Foundation. Since June 2015, Mr. Düren also serves as the Corporate Secretary of the Bank. With 29 years of experience in banking and business administration, Mr. Düren's areas of responsibility are Legal Advisory Services, Litigation Services, Garanti Payment Systems Legal Services, Legal Operation Services and Legal Collections.

Due to the fact that the term of duty of the Board members who were elected on the extraordinary meeting held on 25.01.2019 for a period of three (3) years has expired, the independent board members shall be determined pursuant to the Corporate Governance Communiqué No: II-17.1 of the Capital Markets Board and the members of the Board of Directors shall be elected in accordance with the TCC and the Articles of Association.

According to the Articles of Association, the members of the Board of Directors shall hold office for a term of three (3) years and it is envisaged that three (3) independent board members shall be elected in the composition of nine (9) members Board of Directors.



The background information in relation to the independent board member candidates who are nominated by Group B Shareholder and the board member candidate who is representing C Group privileged share are provided under Annex 1.

### 9. Defining the salaries of the members of the board of directors;

Salaries to be paid to the members of the board of directors for the year 2022 will be determined.

### 10. Resolving on the distribution of profit;

Distribution of Company's profit shall be reseolved in accordance with the Company's Dividend Policy and the Communiqué on Dividends No: II-19.1.

Company's profit for the year 2021 has realized as follows:

- a) The Company's net profit calculated according to the independently audited consolidated financial tables prepared in accordance with the provisions of "Capital Markets Board (CMB) Communique About Financial Reporting in Capital Markets No.II-14.1" is TL 5,761,454,000 for the fiscal year of 2021.
- b) Pursuant to the CMB Communique on Dividends No.II-19.1, the profit after tax amount of TL 5,761,454,000 shall be the base amount for dividend distribution.
- c) Since the Company has already reached the general legal reserve limit in accordance with the Article 519 of Turkish Commercial Code, this reserve is not required to set aside for 2021.
- d) The base for the first dividend shall be TL 5,797,400,185.95 (Pursuant to the CMB regulations, this amount is calculated by adding the TL 35,946,185.95 of donations made in 2021, to the TL 5,761,454,000 of net distributable profit of 2021)
- e) If it is decided to distribute the profit for the 2021 period, the amount, rate and payment time will be determined by the General Assembly at the Ordinary General Assembly meeting to be held for the activity year of 2021.
- 11. Election of the auditor for the purpose of auditing the Company's operations and accounts for the year 2022, pursuant to article 399 of Turkish Commercial Code and article 17/A of the Articles of Association of the Company;

Signing independent audit agreement to examine the Company's operations and accounts for the year 2022 as per the Decision of the Company's Audit Committee which was held in accordance with the Communiqué of the Capital Markets Board No: II-17.1 pursuant to the Corporate Governance Principle No. 4.5.9, article 399 of Turkish Commercial Code and article 17/A of the Articles of Association of the Company will be presented to general assembly's approval.



# 12. Submitting donations and aids policy to the approval of the General Assembly pursuant to Corporate Governance Principles;

Updating the Donation Policy according to the Communiqué on Corporate Governance Principles will be submitted to General Assembly's approval.

## 13. Informing the general assembly about the donations and aids executed in 2021,

Total amount of donations and aids in 2021 is TL 35,946,186.

### 14. Informing General Assembly regarding the Amendment in Disclosure Policy,
