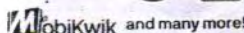
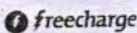
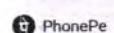
CONSUMPTION TREND (IN UNITS)

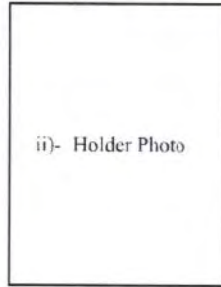

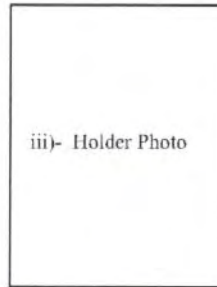

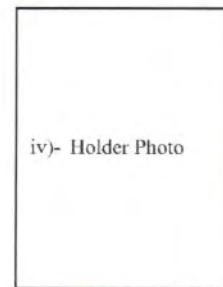
