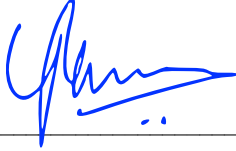
With reference to the above subject, I, Y Ramesh Reddy, S/o Y N C Reddy, hereby request you, pursuant to Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended from time to time, to reclassify myself from the Promoter Category to Public Category. In connection with application for reclassification in accordance with the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, I hereby confirm and certify that:

1. I along with persons related to me together:
 - a. do not hold more than ten percent of the total voting rights in the company.
 - b. do not exercise control over the affairs of the company, directly or indirectly.
 - c. do not have any special rights with respect to the company through formal or informal arrangements including through any shareholder agreements.
 - d. are not being represented on the board of directors (including not having a nominee director) of the Company
 - e. do not act as a key managerial person of the Company
 - f. are not 'wilful defaulter(s)' as per the Reserve Bank of India Guidelines
 - g. are not fugitive economic offender
2. I submit that there exists a SEBI Order in connection with the Brightcom Group Limited matter, which is presently sub-judice before the Hon'ble High Court. In compliance with the said Order, I had stepped down as Director of the Company during the interim directions and have ceased to hold any position as a Key Managerial Personnel. Further, my shareholding in the Company has reduced to 6.49% which is below the threshold limits, and I do not exercise any control or special rights in the Company. Except for the said matter, there is no other regulatory action pending against me.
3. I shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 at all times from the date of re-classification, failing which, I shall be reclassified as promoter/person belonging to the promoter group of the company.
4. I shall comply with the conditions mentioned in the of sub-clauses (iv) and (v) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 for a period of not less than three years from the date of reclassification, failing which, I shall be reclassified as promoter/person belonging to promoter group of the company.

Accordingly, I request you to take the application on record and initiate the process of reclassification as per Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations (Listing Regulations), 2015 to reclassify my status from Promoter/Promoter Group to Public.
