

Independent Auditor's Review Report on Quarterly Unaudited Standalone Financial Results of Onix Solar Energy Limited (Formerly known as ABC Gas (International) Limited) pursuant to the Regulation 33 and 52 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 (as amended).


TO THE BOARD OF DIRECTORS OF **Onix Solar Energy Limited**

1. We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of **Onix Solar Energy Limited (Formerly known as ABC Gas (International) Limited)** (the "Company") for the quarter ended June 30, 2025 (the "Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 and 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) including relevant circulars issued by the SEBI from time to time.
