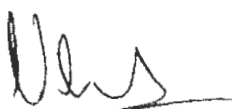

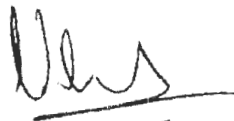
### DECLARATION BY THE ACQUIRER
