COMPANY SECRETARY AS COMPLIANCE OFFICER**

Dear Sir / Madam,

The Board Meeting of the Company was held on 29th May, 2019. The Chairman of the Meeting has placed before the Board the Notice No. NSE/LIST-SOP/REG-6(1)/FINE/73878 dated 12th February, 2019 received from National Stock Exchange of India Limited (NSE) imposing fine of Rs. 92,000/- + 18% GST for non-appointment of Company Secretary as Compliance Officer of the Company as per Reg. 6(1) of the SEBI (LODR) Regulations, 2015 along with the reply filed on 15th February, 2019 requesting waiver of the said fine. NSE has rejected the request for waiver of fine. The Company has paid the fine to NSE Ltd. on 07th March, 2019.

The Board discussed, noted and provided the following response:

'The Company have already appointed Mr. Dhiraj Khandelwal, a member of Institute of Company Secretaries of India (ACS A57483) (PAN CWXPK7534A) as Company Secretary cum Compliance Officer of the Company w.e.f. 07th February, 2019 and intimated the same to National Stock Exchange of India Limited. The Company has paid the fine of Rs. 92,000/- + 18% GST on 07th March, 2019.

The Company has also paid the fine of Rs. 37,000/- + 18% GST on 17th May, 2019.

Further, now the Company is in compliance with the Regulation 6 of the SEBI (LODR) Regulations. Also, the Company will ensure that there will be timely compliance of the SEBI (LODR) Regulations, 2015 and Companies Act, 2013.'
