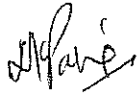
After aforesaid acquisition, the equity share holding of Welspun Promoter Group in Welspun India Limited stands at 73,827,719.

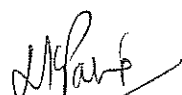

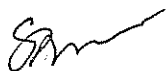
