Post-closing of the voting period on June 1, 2018, the scrutinizer has submitted its report on the results of Postal Ballot (including E-voting) on June 2, 2018.

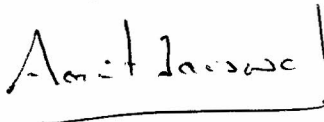

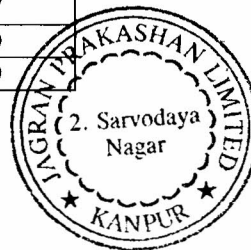

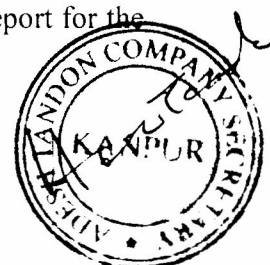

votes cast 'in favour' or 'against' the resolution as stated in the Notice of Postal Ballot, based on the postal ballot received from shareholders and reports generated from E-Voting system provided by the Karvy Computershare Private Limited ("Karvy") the authorized agency to provide e-voting facility, engaged by the Company.

The Postal Ballot Notice dated 27<sup>th</sup> April, 2018 along with the statement setting out material facts under Section 102 of the Companies Act, 2013 were sent to the members of the Company.

The members of the Company holding shares as on cut-off date i.e. 20<sup>th</sup> April, 2018 were entitled to vote on the Resolutions proposed as set out in the Notice.

In this regard, I submit my report as under:

1. The Company had provided facility of casting vote to the members of the Company through postal ballot voting process and also through electronic means.
2. The Company had followed the process as required under Rule 22 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and the Companies (Management and Administration) Amendment Rules, 2015 respectively in respect of providing voting through postal ballot and electronic means.
3. All Postal Ballot forms received up to the close of working hours on 1<sup>st</sup> June, 2018 (05:00 P.M.), being the last date and time fixed by the Company for receipt of the Postal Ballot forms, were considered for Scrutiny for the purpose of this report.
4. The Postal Ballot Forms were kept in my safe custody.
5. The E-Voting period remained open from 3<sup>rd</sup> May, 2018 (09:00 A.M.) to 1<sup>st</sup> June, 2018 (05:00 PM).
6. At the end of the E-voting period, I have unblocked the electronic votes in the presence of two witnesses not in the employment of the Company. Mr. Awashesh Dixit, Address- 30/6 Vishnupuri, Kanpur and Mr. Shivam Gupta, Address- 46/45 Rajgaddi, Hattiy...

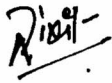

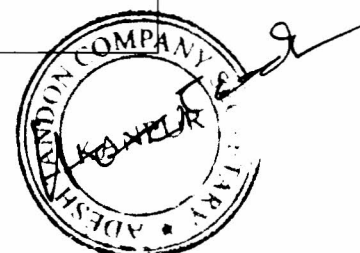

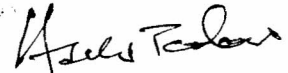
