In continuation of our earlier intimation dated January 10, 2024, and pursuant to Regulation 30 read with Clause 20 of Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that the Company has received an order dated January 14, 2026, in Form APL-04, issued by the Additional Commissioner Grade-II Appeal, GST Appellate Authority, Gautam Budha Nagar, Uttar Pradesh. The said order, passed pursuant to the appeal filed by the Company on December 30, 2023, has modified the earlier GST demand of ₹9,56,04,387 (including a penalty of ₹99,04,968) and has confirmed a revised GST demand of ₹3,39,238 (including a penalty of ₹46,165).

The requisite details, as mandated under Regulation 30 of the SEBI Listing Regulations read with SEBI Master Circular No. SEBI/HO/CFD/POD2/CIR/P/0155 dated November 11, 2024 are enclosed herewith as **Annexure A**.
