Our conclusion on the Statement is not modified in respect of the above matter.

The consolidated unaudited financial results includes the Company's share of net loss after tax of Rs. 0.02 lacs and total comprehensive loss of Rs. 0.02 lacs for the quarter ended 30th June, 2021 as considered in the consolidated unaudited financial results, in respect of three joint ventures, based on their interim financial results which have not been reviewed by their auditors. According to the information and explanations given to us by the Management, these interim financial results are not material to the Company.

Our conclusion on the Statement is not modified in respect of the above matter.

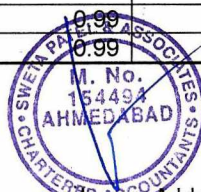
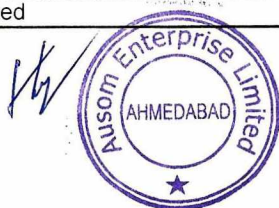
