Ltd. on account of sale of the following entities: First Sentier Investors (Australia) IM Limited (Former: Colonial First State Asset Management (Australia) Limited), First State Investment Management (UK) Limited, First Sentier Investors Realindex Pty Ltd (Former: Realindex Investments Pty Limited), First State Investments International Limited, Mitsubishi UFJ Trust and Banking Corporation and Mitsubishi UFJ Kokusai Asset Management Co., Ltd on November 8th, 2019. These entities directly hold shares in Tata Power Co. Ltd.,
