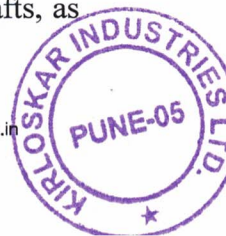
2. Regulation 42 of the SEBI LODR Regulations
