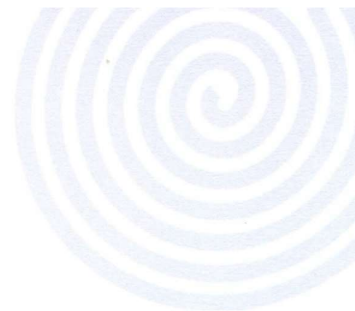

Notice is hereby given that pursuant to the provisions of Section 124(6) of the Companies Act, 2013 ('Act') read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016 ('IEPF Rules'), as amended from time to time, the Interim Dividend declared for the financial year 2015-16, which remained unclaimed for a period of seven years will be credited the IEPF on or after 21st April 2023. The shares on which no dividend has been paid or claimed for seven consecutive years will also be transferred by the Company to the Demat Account of IEPF Authority.

The original share certificates which stand registered in the names of original shareholders will stand automatically cancelled and be deemed non-negotiable.

- Demat form – The Company shall inform the depository by way of corporate action for transfer of shares to the Demat Account of IEPF Authority. The concerned shareholders are requested to claim their unclaimed/ unpaid dividend amounts on or before 10th April 2023. In case, the Company does not receive any communication from the concerned shareholders latest by 10th April 2023, the Company with a view to comply with the provisions of the IEPF rules will proceed to transfer the shares to the Demat Account of the IEPF Authority without any further reference to you.
