This is with reference to the proposal for shifting the registered office of the Company from Mumbai to Ahmedabad. The Board of Directors of the Company had considered and approved at its Board meeting held on August 30, 2025, and subsequently ratified by the members of the Company at the Annual General Meeting held on September 21, 2025, in accordance with the applicable provisions of the Companies Act, 2013, and the Listing Regulations.

Upon further evaluation and comprehensive review of the prevailing business environment and future growth prospects; the Board has observed that Mumbai affords considerable strategic benefits and commercial prospects for the Company. In view of the foregoing, the Board of Directors, in its subsequent deliberations, has resolved to avoid with the furtherance of shifting of the registered office from State of Maharashtra to State of Gujarat.

Accordingly, the earlier proposal approved by the Members for **shifting of the Registered Office stands withdrawn and no further action will be taken in respect of filing applications/petitions with the relevant statutory/regulatory authorities in this regard.**

The Registered Office of the Company shall, therefore, continue to remain at **A-108, 1st Floor, Chikuwadi, Western Express Highway, Andheri East, Mumbai – 400099.**
