The shares of the promoters/promoter group were pledged to the working capital Lenders (Banks) for enhancement of working capital limits in the year 2017. However the appraised facilities were never disbursed by the Lenders. Hence, the Company had requested for return of the pledged shares. In view of failure of the Lenders' to return the pledged securities, the Company filed Commercial Suit No.1416 of 2018 before the Hon'ble Bombay High Court.
