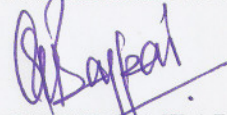

RESULT OF POSTAL BALLOT

Pursuant to Section 110 of the Companies Act, 2013 ("the Act") read with Rule 22 of Companies (Management and Administration) Rules, 2014 ("Rules"), members approval was sought for the resolutions appended to the Postal Ballot Notice dated 2nd May, 2014. Issuance of Bonus Shares by capitalization of Reserves / Securities Premium Account was approved by the members with a requisite majority.

Resolution No. 4 - Special Resolution

Authorization for Borrowings under Section 180(1)(c) of the Companies Act, 2013, was approved by the members with a requisite majority.

Resolution No. 5 - Special Resolution

Creation of Security under Section 180(1)(a) of the Companies Act, 2013, was approved by the members with a requisite majority.

Sub: Submission of Report of Postal Ballot.

I, Dinesh Joshi, Partner, Kanj & Associates, Company Secretaries, Pune, have been appointed by the Board of Directors of **DEEPAK NITRITE LIMITED** (the Company) vide Board Resolution dated 2nd May, 2014 as Scrutinizer for conducting the Postal Ballot voting process.

I submit my Report as under:

1. The Company has completed on 10th May, 2014 the dispatch of Postal Ballots along with postage pre-paid business reply envelopes to its Members whose names appeared on the Register of Members as on 6th May, 2014.
2. The Postal Ballot forms were kept under safe custody.
3. The Postal Ballot received up to 5.00 p.m. on 9th June, 2014, the last date and time fixed by the Company for receipt of Postal Ballot and through NSDL e-voting was considered for scrutiny.
4. Envelopes containing postal ballot forms received after 9th June, 2014 were not considered for my scrutiny.
5. Envelopes containing Postal Ballot forms returned undelivered were also not opened and they are separately kept.
6. I received no Postal Ballot paper in defaced / mutilated condition.



7. As per SEBI CIRCULAR NO CIR/CFD/DIL/2012, dated July 13, 2012 e-voting facility was also made available to all the Members to cast their votes electronically as an optional facility to physical Postal Ballot Form. The facility for e-voting was made available on www.evoting.nsdl.com where the Members were provided with the login id and password which would enable them to vote.
8. A total of 482 Postal Ballots and 60 e voting have been received from the Members which have been scrutinized by me to ascertain the assent or dissent of the Members. Out of 60 e voting, 3 share holders also voted by Postal Ballot. Considering the terms and conditions of the Postal Ballot, in these matters only physical postal ballots were considered. The summary of the Postal Ballot forms received and casting of the votes by e voting is as below:

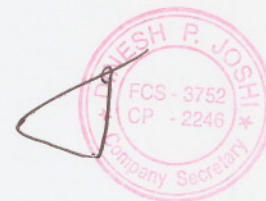
