The Statutory Auditors have carried out a 'Limited Review' of the financial results of the quarter and nine months ended 31 December 2015 as required under Section 33 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015. An unmodified opinion has been issued by the Statutory Auditors and same is being filed with the stock exchange alongwith the above results.
- The Company is engaged in the business of manufacture of Commercial vehicles and spares which is a primary segment for the Company which constitutes a single business segment and accordingly disclosure requirements of Accounting Standard 17, "Segment Reporting", specified under section 133 of the Companies Act, 2013 read with Rule 7 of Companies (Accounts) Rules, 2014 in relation to primary segment are not required to be given. All the business activities of the Company are primarily conducted from locations in India. Therefore, all the revenue and net assets are attributed to Indian operations. Accordingly, no additional disclosure for secondary segment reporting on the basis of geographical operations has been made in the financial results.
- The statement of unaudited financial results for the quarter and nine months ended 31 December 2015 has been prepared following the same accounting policies as those followed in the annual financial statements for the year ended 31 March 2015.
- Previous period figures have been regrouped / recast, wherever necessary to confirm to current period classification.

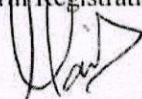
Review Report to the Board of Directors of SML Isuzu Limited
