  - ii) To close the Register of Members and Transfer Books, for Declaration of Dividend for the year 2018-19 and the Annual General Meeting, from Saturday, 21<sup>st</sup> September, 2019 to Monday, 30<sup>th</sup> September, 2019;
  - iii) That the Cut Off/Record Date would be Friday, 20<sup>th</sup> September, 2019;
  - iv) That the Dividend Pay Out Date would be Friday, 25<sup>th</sup> October, 2019;
  - v) That the eVoting period would be from Wednesday, 25<sup>th</sup> September, 2019 to Sunday, 29<sup>th</sup> September, 2019.
