Brief Profile of Ms. Smita Anand

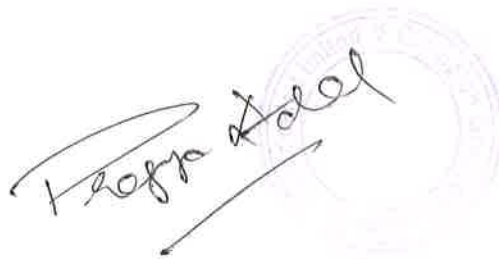
