4. The company operates only in one business segment viz. 'manufacturing and sales of agro chemicals' and hence no separate information for primary segment wise disclosure is required.
5. The figures for the quarter ended 31st March, 2026 and 31st March, 2025 are the balancing figures between the audited figures in respect of the full financial year and the unaudited published figures upto nine months of the relevant financial year.
6. There were no complaints from investors outstanding at the quarter & year ended 31st March, 2026 and the Company has not received any complaints during the quarter & year ended 31st March, 2026.
7. On November 21, 2025, the Government of India notified the four labour codes, the code on Wages 2019, Industrial Relations Code 2020, Code on Social Security, 2020 and the Occupational Safety, Health and Working Conditions Code 2020 consolidating 29 existing labour laws. The Company has assessed and disclosed the incremental impact of these changes on the basis of actuarial report, internal assessment with guidance provided by the Institute of Chartered Accountants of India. The Company has recognized a provision towards past service cost on gratuity payable to employees amounting to Rs. 39.54 lakhs during the year ended March 31, 2026 which is included under "Exceptional Item".
