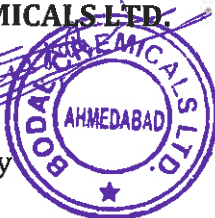

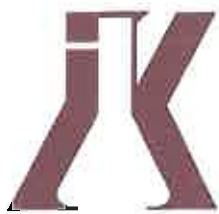

PRESS RELEASE

Ahmedabad, April 07, 2016: Bodal Chemicals Ltd had applied for Environment Clearance (EC) from Ministry Of Environment, Forests and Climate change, New Delhi for Expansion of its Dyes and Dyes Intermediates Manufacturing capacity (from 2,200 MTPM to 6,000 MTPM) and Co-generation Power Plant (5MW) at our Unit 7, Village Dudhwada, Tehsil Padra, District Vadodara, Gujarat.

Our said application has been considered by Expert Appraisal Committee (EAC) working under the said ministry and has granted approval for the Expansion of Dyes and Dyes Intermediates Manufacturing capacity (from 2,200 MTPM to 6,000 MTPM) and Co-generation Power Plant (5MW).

Bhavin S. Patel, Executive Director commented that with this approval in place, company is in a position to plan to enhance its dyestuff manufacturing capacity at very low capital cost compare to cost of green field project or cost required for commencement of new plant in this sector. This is considering the ready civil structure, other infrastructure and utilities at our existing plant at the location.

After complying the stringent norms and lengthy process it took more than 5 years for the company to get the said approval. It is also important to note that in the increasing trend of per unit power cost scenario, once 5MW power plant is commissioned, company will able to save significantly in power cost.
