Centuryply's operations in Laos

Century Plyboards (India) Ltd. had incorporated a subsidiary in the name of Century Ply (Singapore) Pte. Ltd. in Singapore on 2nd December, 2014 *inter alia* with the object of manufacturing and trading in plywood & all wood products & materials.

This Subsidiary Company has entered into an arrangement with an entity named Soksay Wood Factory Co. Ltd. in Laos for manufacture and supply of veneer to it. Pursuant to this arrangement, Century Ply (Singapore) Pte. Ltd. had installed its plant and machinery in the premises of Soksay Wood Factory Co. Ltd., using which the latter would process and convert logs in to veneer and sell exclusively to Century Ply (Singapore) Pte. Ltd. and/ or to Century Plyboards (India) Ltd.

This arrangement with Soksay Wood Factory Co. Ltd. was originally entered into by a Vietnamese Company named Vietdutch International JSC but was transferred to Century Ply (Singapore) Pte. Ltd. Consequently and in consideration thereof, it was agreed to issue and allot 49% shareholding in Century Ply (Singapore) Pte. Ltd. to Vietdutch International JSC and/ or to its Promoters/ nominees.

Recently, Century Plyboards (India) Ltd. has also received in-principle clearances from a SEZ in Laos for setting up its own wood-based unit. The Company is in the process of taking ahead this venture either directly or through its subsidiary Century Ply (Singapore) Pte. Ltd.
