Chandrasekaran Associates, Company Secretaries, who were appointed as the Scrutinizer for conducting the remote e-voting process as well as voting through ballot process at the said AGM, will submit their report detailing the consolidated result on remote e-voting as well as the ballot process not later than

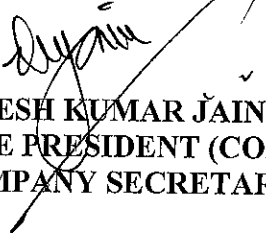
two days of conclusion of the said AGM and once declared, the result shall be notified to the stock exchanges and uploaded on the website of the Company and Karvy.
