Press Release

Mumbai, October 31, 2014: KEC International Ltd. (KEC), a global infrastructure EPC major, an RPG Group company, today announced its unaudited consolidated results for the quarter ended September 30, 2014.

Consolidated Financial Performance

Net Revenue for the quarter stands at ₹ 2,173 crore as against ₹ 1,778 crore in the corresponding quarter of previous year, an increase of 22% Y-o-Y.

EBITDA for the quarter stands at ₹ 121 crore as against ₹ 112 crore in the corresponding quarter of previous year, an increase of 8% Y-o-Y.

Profit After Tax for the quarter stands at ₹ 20.3 crore as against ₹ 22.1 crore in the corresponding quarter of previous year, a decrease of 8.2% Y-o-Y.

Order Intake and Order Book

During the quarter, apart from new orders of ₹ 1,029 crore announced earlier, the company has secured additional orders of ₹ 71 crore in its Transmission & Distribution business.

Including these orders, the **order book** currently stands at ₹ 9,322 crore, of this 61% is from outside India.

The formalities for Thane Land Sale announced in March 2014 are expected to be completed by Q3FY15.
